



RESOLUTION 21-103

Resolution Authorizing the Award of Construction Contract to Black Rock Enterprises, LLC for the 2021 Pathways Project in an Amount Not to Exceed \$264,256.00

WHEREAS, in response to a duly advertised Notice to Bidders under the New Jersey Local Public Contracts Law, *N.J.S.A. 40A:11- 1 et seq.*, on March 11, 2021, Princeton received the following seven (7) bids for the 2021 Pathways Project:

1. Black Rock Enterprises, LLC. of Old Bridge, New Jersey - \$264,256.00
2. Earle Asphalt Company of Farmingdale, New Jersey - \$275,413.13
3. Landtek Construction LLC doing business as United Terrain Group of Morganville, New Jersey - \$294,333.00
4. T. Fiotakis Construction, LLC of Edison, New Jersey - \$324,325.00
5. S&G Paving of Jamesburg, New Jersey - \$338,159.00
6. Pave Rite Inc. of Bridgewater, New Jersey - \$366,082.95
7. S. Brothers Inc. of South River, New Jersey - \$438,694.05

WHEREAS, the Engineer has reviewed Black Rock Enterprises' bid and recommends that the contract be awarded to Black Rock Enterprises, LLC as the lowest responsible bidder; and

WHEREAS, the Municipal Attorney's Office has reviewed the bid submitted by Black Rock Enterprises, LLC and finds that its submission is in compliance with the bidding requirements for same; and

WHEREAS, Princeton has appropriated sufficient funds for this project in capital accounts 04-215-17-037-076-324 (\$200,289.41) and 04-215-19-021-076-345 (\$63,966.59) as certified by Sandra Webb, Chief Financial Officer; and

WHEREAS, Princeton wishes to award a contract to undertake and complete said work to the aforementioned lowest responsible bidder.


NOW, THEREFORE, BE IT RESOLVED by the Princeton Council in the Municipality of Princeton as follows:

The Mayor and Clerk are hereby authorized and directed to enter into an agreement with Black Rock Enterprises, LLC for a sum not to exceed \$264,256.00; to undertake and complete the 2021 Pathways Project, all in accordance with the terms and conditions with the Bid Documents which are on file in the office of the Clerk.
