RESOLUTION 21-76

**Resolution Ratifying the Award of an Agreement with North American Pipeline Service in the Not to Exceed Amount of \$8,500.00, and Authorizing Payment for Emergency Repair to a Sanitary Sewer Force Main on Crooked Tree Lane**

**WHEREAS**, by Memorandum dated January 20, 2021, the Sewer Design Engineer advised the Administrator of the need for Princeton to undertake an emergency repair to the sanitary sewer system, and specifically the sanitary sewer force main on Crooked Tree Lane, near the intersection with Herrontown Road in Princeton; and

**WHEREAS**, as detailed in said January 20, 2021 Memorandum, which is incorporated herein as if fully restated, Princeton solicited proposals from various contractors to complete the emergency repair, including a proposal from North American Pipeline Service of Freehold, New Jersey; and

**WHEREAS**, pursuant to the Local Public Contracts Law (LPCL), N.J.S.A. 40A:11-6, and as authorized by section 2-1.6(o) of the Princeton Code, and based on the Engineer's January 20, 2021 Memorandum, the Administrator determined that an emergency affecting the public health and safety existed, necessitating the immediate performance of the work by North American Pipeline Service for the quoted sum of \$8,500.00; and

**WHEREAS**, the value of this contract shall not exceed the applicable bid threshold; and

**WHEREAS**, North American Pipeline Service has satisfactorily completed the emergency repair work and is entitled to payment therefor; and

**WHEREAS**, the final cost of the project is \$8,500, as shown on the itemized invoices; and

**WHEREAS**, the Chief Financial Officer has certified that sufficient funds are available

to pay for said services from 04-215-17-031-089-301.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Municipality of Princeton, County of Mercer, State of New Jersey, as follows:

1. Pursuant to N.J.S.A. 40A:11-6, the Council hereby ratifies the Administrator’s award of the emergency repair agreement for \$8,500.00 to North American Pipeline Service, based on the reasons set in the “Whereas” clauses and the January 20, 2021 Memorandum from the Engineer.
2. Payment in the amount of \$8,500.00 shall be made to North American Pipeline Service.
3. A copy of this Resolution shall be placed on file in the Office of the Clerk.
