



RESOLUTION 21-215

Resolution Authorizing the Use of State Contract A42270 (T No.: T-0849) in the Not to Exceed Amount of \$80,208.30 with Independence Contractors for the Final Completion of the Masonry Wall at the Municipal Fleet Fuel Facility on Mount Lucas Road

WHEREAS, N.J.S.A. 40A:11-12 provides that a contracting unit may, without advertising for bids, purchase any materials, supplies or equipment under any contract entered into on behalf of the State by the Division of Purchase and Property in the Department of Treasury; and,

WHEREAS, the municipality of Princeton has authorized purchases under the appropriate State Contract, and utilized the bidding advantage done by the State; and

WHEREAS, the Municipality of Princeton seeks to extend the existing unfinished masonry wall, and install a brick veneer and limestone cap on the wall, at the municipal fleet fuel facility on Mount Lucas Road; and

WHEREAS, Independence Constructors, Inc., 1200 Route 22 East, Bridgewater, New Jersey 08807, was awarded New Jersey State Contract #A42270 (T No.: T-0849) for installation, removal, and repair to aboveground fuel tanks; and

WHEREAS, New Jersey State Contract #A42270 (T No.: T-0849) expires on August 28, 2021; and

WHEREAS, the Engineering Department recommends encumbering a not to exceed amount of \$80,208.30, contingent upon receipt of a responsive quote from Independence Constructors, Inc.; and

WHEREAS, the Chief Financial Officer has certified that there are sufficient funds available in capital accounts 04-215-18-076-324 (\$9,589.40) and 04-215-19-021-076

(\$70,618.90) for this contract.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of Princeton, County of Mercer, State of New Jersey, as follows:

1. The Chief Financial Officer is authorized to encumber up to \$80,208.30 for the purchase of items from the above vendor under the State Contract noted above.
2. These expenditures shall be charged to the appropriate capital account.
