HEALTH OFFICER'S MONTHLY REPORT – Jan/Feb 2013

Mr. Henry gave a brief review of the meeting he attended he mentioned he was re-elected President of the Mercer County Health Officers Association.

Mr. Henry met with the State Health Department to discuss the future of Sexually Transmitted Disease Services in NJ. One of the things discussed was possible grant availability.

Mr. Henry and Dr. DiFerdinando attended the NJ Association of City and County Health Officials meeting. The Commissioner of Health spoke. Dr. DiFerdinando represented the Board of Health.

Mr. Henry participated in a meeting held by the NJ Prevention Network. The Health Department is participating in environmental scan of policies and health disparities in Mercer County.

Mr. Henry explained that this time work is being done on Grants to look at environmental scans for Mercer County. The health department is working with four interns from Rutgers and with other municipalities.

Mr. Henry reported that the department is working closely with Princeton University regarding the Norovirus outbreak.

Dr. Rojer congratulated Mr. Henry on being re-elected President of the Mercer County Health Officers Association.

Health Inspectors January 2013 Monthly Report:

Dr. Kahn enquired as to what type of animal specimen was sent to the lab for testing.

Mr. Henry indicated that it was a Silver Nose Bat and the results were negative.

After more discussions on the report a motion was made by Dr. Rojer and seconded by Ms. Hill this carried on a voice call vote: Ayes (7) Nays (0)

Ms. Howard introduced Councilman Simon

Mr. Henry gave an overview on the various aspects of service during and after hurricane Sandy.

Ms. Hersh indicated that shelters should have been identified before the event, and thought that these shelters should have emergency generators and should be designated as shelters. The Hospital emergency room was used by residents as a shelter for such things as charging their phones, also the elderly that came to the Hospital for fear of not being able to keep their appointments.

Ms. Howard indicated that a warming center was available in Princeton this center was not designated before the storm.

Dr. Kahn indicated that given the global climate changes the Township should be more prepared since these events are happening more often. It is important to be better prepared, thought should be given to burying the power lines to alleviate the loss of power.

Mr. Topolosky indicated that this was a subject that has been discussed for the last seven years and it is time for something to be done.

Ms. Bidwell-Bates reminded the Board that many of the elderly are not electronically equipped and plans should be made for them as well.

Mr. Topolosky asked Councilman Simon with the new task force in place what are the steps be taken and when.

Councilman Simon indicated the group met to outline the scope of communications, warming centers, roads and public health at this time nothing has been decided.

Councilman Simon invited any member with suggestions he would welcome them.

Mr. Henry also indicated that a memorandum of understanding with a vendor for such things as water.
