In 2020, we began a community discussion about Witherspoon Street, focusing on the downtown area between Nassau Street and Paul Robeson. This May 2021 design meeting is intended to continue the community discussion about Witherspoon Street from Paul Robeson to Valley Road. We are seeking your ideas and feedback for pedestrian, bicyclist, transit and motor vehicle improvements; street lighting; tree and other vegetation additions; public art; seating and other street furniture; and any other features that will enhance the vibrancy of the corridor.

On May 18, Princeton staff and our consultant, T&M Associates, will give a short presentation at 6:10 pm to review the goals of this master planning process, discuss the agenda below and to provide more details on the project schedule. The agenda will include discussion about the following items for the Paul Robeson Place to Valley Road section:

- 1. Existing conditions
- 2. Proposed improvements from Nassau Street to Paul Robeson Place
- 3. Bike facilities
- 4. Pedestrian facilities

- Transit facilities
- 6. Parking and traffic movements
- 7. Stormwater and sanitary sewer infrastructure, including green infrastructure
- 8. Tree removals and replacements
- 9. Street lighting
- 10. Public art and other street amenities such as benches, bike racks, bike corrals, newspaper receptacles, and trash receptacles
- 11. Wayfinding signage
- 12. Other utility company improvements. Utility companies and property owners are advised to make necessary upgrades to water, electric, telecommunications, and natural gas systems now to avoid the 5-year moratorium that will be enacted upon completion of roadway paving. PSE&G Gas has advised that work is necessary on their main and services in this corridor.
