

NOTICE TO BIDDERS

Notice is hereby given that sealed bids will be received by the Municipality of Princeton in the County of Mercer, State of New Jersey, at the Municipal Building, 400 Witherspoon Street, Princeton, New Jersey 08540 on **June 4, 2013 at 2:30 P.M.** prevailing time and place publicly opened and read for the following:

IMPROVEMENTS TO MOORE STREET, PARK PLACE, VANDEVENTER AVENUE, AND WILLOW STREET

This project includes the following construction: 1100' of 8" sanitary sewer lining; 750' of 8" sanitary sewer main replacement; 1000' of 12" sanitary sewer main replacement (6-16' deep); sewer lateral replacement utilizing trenchless and open cut techniques; 110' of 29"x45" HE RCP installation; 120' of 15" RCP installation; 110' of 36" RCP installation; 90 CY DGABC; 5,500 SY bituminous concrete milling; 2,600 combined tons of HMA 19M64 base course, and HMA 9.5M64 leveling and surface courses; 500' of resetting granite curb; 740' of new concrete curb; 1,920 SY of concrete sidewalk and driveway aprons; and other related miscellaneous work. Resurfacing of Vandeventer Avenue may take place during night time operations. Bidders are advised that the contract time is **one hundred and twenty (120) calendar days.**

Plans, specifications and bid documents may be obtained for the non-reimbursable sum of \$50.00 at the office of the Municipal Engineer, located at the Princeton Municipal Building, 400 Witherspoon Street, Second Floor, Princeton, New Jersey between the hours of 9:00 a.m. and 5:00 p.m., Monday through Friday. In accordance with 297 N.J. Super. 473, 688 A.2d 632, the bidder's list will not be disclosed.

All bids shall be on approved bid forms which shall be submitted in sealed envelopes, addressed to the Municipal Clerk, Municipal Building, 400 Witherspoon Street, First Floor, Princeton, New Jersey 08540, bearing the name and address of the bidder and the purpose for which the bid is submitted. Required documents to be submitted are set forth in Paragraph 1C of the section of the specifications entitled "Instructions to Bidders".

Bids may be submitted in person or by mail and they will be received at the Municipal Clerk's Office and publicly opened, examined and announced. No bids will be received after the above-designated time. The Municipality assumes no responsibility for the loss or the non-delivery of any bid sent to it prior to the bid opening.

Each bid shall be accompanied by a certified check, bank cashier's check or bid bond of an amount equal to at least ten percent (10%) of the total bid, but not to exceed \$20,000.00, payable to the Municipality of Princeton and a Consent of Surety. The surety shall be bound to furnish performance and payment bonds as required in the section of the specifications entitled "Instructions to Bidders".

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq., and N.J.A.C. 17:27 - 1.1 et seq., (Affirmative Action Rules), and P.L. 1977, c.33, Stockholder or Partnership Disclosure Statement, and all other requirements as set forth in the Instructions to Bidders.
