RESOLUTION OF PRINCETON, IN THE COUNTY OF MERCER, NEW JERSEY MAKING APPLICATION TO THE LOCAL FINANCE BOARD PURSUANT TO N.J.S.A. 40A:2-51

WHEREAS, Princeton, in the County of Mercer, New Jersey ("Princeton"), desires to make application to the Local Finance Board for its approval of proposed ordinance authorizing the funding of an emergency appropriation for expenses related to the consolidation of the Township of Princeton and the Borough of Princeton.

WHEREAS, Princeton believes that:

- (a) it is in the public interest to accomplish such purposes;
- (b) said purposes are for the health, welfare, convenience or betterment of the inhabitants of Princeton;
- (c) the amounts to be expended for said purposes are not unreasonable; and
- (d) the proposals are an efficient and feasible means of providing services for the needs of the inhabitants of Princeton and will not create an undue financial burden to be placed upon Princeton;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF PRINCETON, IN THE COUNTY OF MERCER, NEW JERSEY as follows:

Section 1. The Application to the Local Finance Board is hereby approved, and Princeton's Bond Counsel, along with such other representatives of Princeton are hereby authorized to prepare such application and to represent Princeton in matters pertaining thereto.

Section 2. The Clerk of Princeton is hereby directed to prepare and file copies of the proposed ordinances with the Local Finance Board as part of such application.

Section 3. The Local Finance Board is hereby respectfully requested to consider such application and to record its findings, recommendations and/or approvals as provided by the applicable New Jersey Statute.
