Altman have a septic system but were billed sewer charges in error due to a system glitch the year the revaluation went on the books.

**A RESOLUTION AUTHORIZING A SEWER REFUND

WHEREAS, the 2014 Extended Tax Duplicate listed Block 202 Lot 11 as owned by Robert A. & Jane R. Altman, and;

WHEREAS, the sewer fee was incorrectly billed in 2010 by \$368.55, 2011 by \$380.26, 2012 by \$386.10, 2013 by \$287.05 and by 2014 1st & 2nd quarter for \$143.53, and the owners paid those amounts, and;

WHEREAS, it is the desire of the Mayor and Council of Princeton to refund bl-202 lot-11 the amount of \$368.55 for 2010, \$380.26 for 2011, \$386.10 for 2012, \$287.05 for 2013 and \$143.53 for 2014 overpaid sewer tax and remove the billing for 3rd & 4th 2014 for 175.22.

NOW, THEREFORE, BE IT RESOLVED on this 28th day of July, 2014, by the Mayor and Council of Princeton, County of Mercer, State of New Jersey, that sewer fees totaling \$1,740.71 are hereby canceled and the Princeton Tax Collector is authorized to adjust her records for 2014, and is hereby released from the collection of the same.
