Re: **No Parking Ordinance – Scott Lane**

Residents that reside in the neighborhood of Scott Lane and Bainbridge Street have expressed safety concerns caused by vehicles that park along both sides of the southern end of Scott Lane, near Nassau Street. The parking of these vehicles in this area creates difficulty for vehicles to enter or exit Scott Lane at this location.

Engineering Department and Police Department staff recommend that the current safety issue be addressed by prohibiting parking along the eastern side of Scott Lane at this location. The following addition to Section 19-22 of the Code pertaining to “no parking at any time” is recommended.

**“Scott Lane, Eastern side, between Nassau Street and a point 200’ north of Nassau Street”**

Attached hereto please find a proposed parking prohibition ordinance for consideration by the Princeton Council at their meeting on February 18, 2014.

We have discussed the proposed parking prohibition with the abutting property owner at this location and they would have no objection. In addition, the Traffic and Transportation Committee has considered this matter and concurs with this recommendation.

**AN ORDINANCE CREATING  
A NO PARKING ZONE ON A  
PORTION OF SCOTT LANE  
AND AMENDING THE  
"CODE OF THE BOROUGH  
OF PRINCETON, NEW  
JERSEY, 1974".**

**BE IT ORDAINED** by the Mayor and Council of Princeton as follows:

Section 1. Section 19-22 of the "Code of the Borough of Princeton, New Jersey, 1974" which establishes no parking zones within Princeton is amended by adding thereto the following designation in alphabetical order for Scott Lane and shall read as follows:

*Scott Lane.* Eastern side, between Nassau Street and a point 200 feet north of Nassau Street.

Section 2. The appropriate no parking signs shall be posted to implement this no parking regulation.

Section 3. This Ordinance shall take effect upon its passage and publication as Required by law.
