

**AN ORDINANCE BY THE TOWNSHIP OF PRINCETON CONCERNING THE SPEED LIMIT ON VARIOUS ROADS, AMENDING THE "CODE OF THE TOWNSHIP OF PRINCETON, NEW JERSEY, 1968".**

WHEREAS, Ordinance No. 2009-\_\_\_, adopted by the Princeton Township Committee on October\_\_\_, 2009, accepted various streets as part of the Township's public road system; and

WHEREAS, the Princeton Township Police Department Traffic Safety Bureau has reviewed the identified roads, and in consultation with the Township's Engineering Department, has recommended that the appropriate speed limit for said roads is twenty-five (25) miles per hour; and

WHEREAS, the Township Committee wishes, therefore, to establish the speed limit on the various roads as twenty-five (25) miles per hour.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of the Princeton as follows:

1. Section 11.2(e) of said Code, which establishes a twenty-five (25) mile per hour speed limit for various streets or parts of streets in the Township, is amended by adding thereto the following designated Roads:

BOGART COURT, both directions, entire length.

CHRISTOPHER DRIVE, both directions, entire length.

CRADLEROCK ROAD, both directions, entire length.

DAVIES DRIVE, both directions, entire length.

DERWENT DRIVE, both directions, entire length.

ETTL CIRCLE, both directions, entire length.

FITCH WAY, both directions, entire length.

FREDERICK COURT, both directions, entire length.

GEORGE DRIVE, both directions, entire length.

GRASMERE WAY, both directions, entire length.

KATIE'S POND ROAD, both directions, entire length.

MAIDENHEAD ROAD, both directions, entire length.

MEETING HOUSE COURT, both directions, entire length.

PETTIT PLACE, both directions, entire length.

RUNNING CEDAR ROAD, both directions, entire length.

STONE CLIFF ROAD, both directions, entire length.

STONEWALL CIRCLE, both directions, entire length.

TREWBRIDGE COURT, both directions, entire length.

VAN MARTER COURT, both directions, entire length.

WALKER DRIVE, both directions, entire length.

WINDERMERE WAY, both directions, entire length.

WOODHULL LANE, both directions, entire length.

2. Regulatory and warning signs shall be erected and maintained to effect the above-referenced twenty-five (25) mile per hour speed limit as authorized by the New Jersey Department of Transportation.
3. This Ordinance shall take effect upon its passage and publication as provided for by law.
