

**AN ORDINANCE BY THE TOWNSHIP OF
PRINCETON, COUNTY OF MERCER,
STATE OF NEW JERSEY CONCERNING
FEES FOR GOVERNMENT RECORDS
AND NON-GOVERNMENT RECORDS,
AND AMENDING CHAPTER II OF THE
“CODE OF THE TOWNSHIP OF
PRINCETON, NEW JERSEY, 1968”.**

BE IT ORDAINED by the Township Committee of the Township of Princeton as follows:

1. Subsection 2-54(c) of the “Code of the Township of Princeton, New Jersey, 1968” (hereinafter “the Code”) concerning the charges for copies of public records is hereby repealed in its entirety and replaced with the following:

(c) *Fee schedule.* The fees for copies of government records shall be:
