IMPORTANT NOTICE REGARDING MOUNT LUCAS ROADWAY WORK

ROADWAY IMPROVEMENT WORK BETWEEN JEFFERSON ROAD AND CHERRY HILL ROAD

Subbase repairs, base pavement course installation work and minor concrete work are planned to continue on both sides of Mount Lucas Road between Jefferson Road and Cherry Hill Road on Monday, July 20th, through Friday, July 24th, weather permitting. In order to provide for this work, Mount Lucas Road will be closed to through traffic from Jefferson Road to Cherry Hill Road during working hours of 7 am to approximately 6 pm. When work is taking place on Mount Lucas Road at Laurel Road, Laurel Road will be closed to through traffic from Mount Lucas Road to Jefferson Road.

ROADWAY IMPROVEMENT WORK BETWEEN EWING STREET AND STUART ROAD EAST

Minor belgian block curb work is planned to take place on Mount Lucas Road at Redding Circle on Wednesday, July 22nd, through Friday, July 24th, weather permitting. While this work is proceeding, Mount Lucas Road will be closed to through traffic from Ewing Street to Poor Farm Road during working hours of 7 am to approximately 6 pm. Redding Circle will remain accessible.

NEW JERSEY AMERICAN WATER MAIN AND SERVICES IMPROVEMENT WORK

On Monday, July 20th, and through the middle of the week, weather permitting, the New Jersey America Water (NJAW) company contractor, CRJ Construction, will continue the replacement of house water services and installation/replacement of fire hydrants within the public right-of-way between Jefferson Road and Ewing Street. To provide for this work, Mount Lucas Road will be closed from Ewing Street to Jefferson Road during working hours of 7 am to approximately 5 pm. Once the work is finished on this section, CRJ Construction will begin the house water services and hydrant work within the right-of-way on Mount Lucas Road between Cherry Hill Road and Laurel Road. In order to provide for this work, Mount Lucas Road will be closed to through traffic from Jefferson Road to Cherry Hill Road during working hours of 7 am to approximately 5 pm. When work is taking place on Mount Lucas Road at Laurel Road, Laurel Road will be closed to through traffic from Mount Lucas Road to Jefferson Road. The switchover to the new house water service will require shut-off of the water for approximately 15 minutes. The switchover will be done one house at a time and will take place between the hours of 9 am and 3 pm. The contractor will knock on your door prior to shutting the water off to your house and after the switchover is complete.

Should inclement weather occur, the work will proceed the following business day. Mount Lucas Road will reopen at the end of each work day. Residents are advised to use caution when driving within the road closure area and allow additional time for travel. Provisions will be made for emergency services vehicles and for continued services such as brush collection, mail delivery, garbage and recycling pick-up.
