**AN ORDINANCE CONCERNING
MISCELLANEOUS MOTOR VEHICLE
AND TRAFFIC REGULATIONS AND
AMENDING THE "CODE OF THE
TOWNSHIP OF PRINCETON, NEW
JERSEY, 1968"**

BE IT ORDAINED by the Township Committee of the Township of Princeton
as follows:

1. Chapter 11 of the "Code of the Township of Princeton, New Jersey, 1968"
which sets forth various motor vehicle and traffic regulations for the
Township of Princeton is amended as follows:

1. Sec. 11-45 which designates traffic control signal locations within
the Township is amended by adding thereto in alphabetical order
the following new designations:

Alexander Street and Lawrence Drive

Harrison Street North and Bunn Drive

The Great Road and Princeton Day School
driveway

The Great Road and Cherry Valley Road.

2. Sec. 11-3.1 which establishes various lane use reservations within
the Township is amended by adding thereto in alphabetical order
the following new lane use locations:

- *The Great Road.* At the intersection of Princeton Day
School driveway, traveling in a northerly direction, left lane
for left turn only onto the Princeton Day School driveway

westbound; right lane for right turns and straight ahead only.

The Great Road. At the intersection of Princeton School driveway, traveling in a southerly direction, left lane for straight ahead only; right lane for right turns only onto the Princeton School driveway westbound.

- *Harrison Street North.* At the intersection of Bunn Drive, traveling in a southerly direction, left lane for left turns only onto Bunn Drive eastbound; right lane for straight ahead only.

Bunn Drive. At the intersection of Harrison Street North, traveling in a westerly direction, left lane for left turns only; right lane for right turns only.

- *Harrison Street North.* At the intersection of Valley Road, traveling in a southerly direction, left lane for left turns only onto Princeton Shopping Center driveway eastbound; middle lane for straight ahead only; right lane for right turns and straight ahead only;

Harrison Street North. At the intersection of Valley Road, traveling in a northerly, left lane for left turns only onto Valley Road westbound; middle lane for

straight ahead only; right lane for right turns and straight ahead only.

- *Alexander Street.* At the intersection of Lawrence Drive, traveling in a southerly direction, left lane for left turns only onto the driveway eastbound for 350 Alexander Street; right lane for right turns and straight ahead only.

Alexander Street. At the intersection of Lawrence Drive, traveling in a northerly direction, left lane for left turns only onto Lawrence Drive westbound; right lane for right turns and straight ahead only.

- *Mercer Road.* At the intersection of Lovers Lane and Olden Lane, traveling in an easterly direction, left lane for left turns only onto Lovers Lane; right lane for right turns and straight ahead only.

Mercer Road. At the intersection of Lovers Lane and Olden Lane, traveling in a westerly direction, left lane for left turns only onto Olden Lane; right lane for right turns and straight ahead only.

3. Sec. 11-23.10 concerning parking regulations within the police department parking yard is amended to read as follows:

As used in this division "police department parking yard" means that certain parking yard in and belonging to the township and located within the following areas:

- a. Located northerly of the Princeton Township Police Department main building entrance between said building and the south side of Valley Road.
 - b. Located easterly of the Princeton Township Recreation Department building between said building and the Princeton Township Municipal building.
 - c. Located northerly of the Princeton Township Recreation Department building said parking spaces located along and adjacent to the south side of NJ State Highway Route 206.
4. Section 11-23.12 concerning regulations involving parking stalls within the Police Department parking yard is amended to read as follows:

No person shall park any vehicle in the police department parking yard or along the driveway leading to and from the parking yard except within a parking stall designated by pavement markings, and no person shall park any vehicle within any parking stall designated or reserved for official police department vehicles unless said vehicle is a marked or unmarked official police vehicle.
5. Regulatory and warning signs shall be posted to implement these motor vehicle regulations as required by the New Jersey Department of Transportation.

6. This Ordinance shall take effect upon its passage and publication as provided for by law.
