

2014-42 AN ORDINANCE CREATING NO PARKING ZONES ON PARK PLACE AND PORTIONS OF MOORE STREET AND HAMILTON AVENUE AND AMENDING THE "CODE OF THE BOROUGH OF PRINCETON, NEW JERSEY, 1974".

BE IT ORDAINED by the Mayor and Council of Princeton as follows:

Section 1. Section 19-22 of the "Code of the Borough of Princeton, New Jersey, 1974" which establishes no parking zones within Princeton is amended by adding thereto the following designation in alphabetical order for Hamilton Avenue, Moore Street, and Park Place and shall read as follows:

Section 19-22. No parking zones.

(a) No parking at any time.

(1) Designated. No person shall park a vehicle at any time upon any of the following streets or parts thereof:

Hamilton Avenue, south side, from the east curb line of Moore Street to a point one hundred and four feet easterly.

Moore Street, west side, from Route NJ 27 (Nassau Street) to a point fifty feet northerly.

Moore Street, west side, from the north curb line of Park Place to a point fifty feet northerly.

Moore Street, west side, from a point one hundred and seventy five feet north of the north curb line of Park Place to a point seventy five feet northerly.

Moore Street, west side, from a point fifty-five feet south of the south curb line of Wiggins Street to a point one hundred and fourteen feet north of the north curb line of Wiggins Street.

Moore Street, west side, from a point fifty-five feet south of the extended south curb line of Houghton Road to a point fifty-five feet north of the extended north curb line of Houghton Road.

Moore Street, west side, from a point sixty-eight feet south of the south curb line of Franklin Avenue to a point seventy-two feet north of the north curb line of Franklin Avenue.

Park Place, south side, from Vandeventer Avenue to a point thirty feet easterly.

Park Place, south side, from a point forty feet west of the extended west curb line of Madison Street to a point 45 feet east of the extended east curb line of Madison Street.

Park Place, south side, from the west curb line of Moore Street to a point eighty-two feet westerly.

Section 2. Section 19-23 of said Code establishing nonmetered on-street parking zones is amended and shall read as follows:

Sec. 19-23. Nonmetered on-street parking zones.

(d) Parking time limited to two hours.

(1) No person shall park a vehicle for longer than two hours at any time between the hours of 8:00 A.M. and 6:00 P.M., Monday through Saturday, upon any of the following streets or parts of streets:

Moore Street, west side, from a point fifty feet north of the north curb line of Park Place to a point one hundred twenty-five feet northerly.

Moore Street, west side, from a point fifty-five feet south of the south curb line of Wiggins Street to a point three hundred and ten feet southerly.

Section 3. Section 19-24 of said Code establishing metered on-street parking zones is amended and shall read as follows:

Sec. 19-24. Metered on-street parking zones.

(f) Parking time limited to ten hours.

(3) Type three meters. No person shall park a vehicle for longer than ten hours at any time between the hours of 8:00 A.M. and 7:00 P.M., Monday through Saturday, upon any of the following streets or parts of streets:

Park Place, south side, from a point thirty feet east of the east curb line of Vandeventer Avenue to a point forty feet west of the extended west curb line of Madison Street and from a point forty-five feet east of the extended east curb line of Madison Street to a point eighty-two feet from the west curb line of Moore Street.

Section 4. Section 19-37 of said Code establishing the Princeton High School / Westminster Choir College neighborhood permit parking district is amended and shall read as follows:

Sec. 19-37. Princeton High School/Westminster Choir College Neighborhood Permit Parking District.

(a) Defined. The Mayor and Council of the Borough of Princeton have determined that there is an acute problem providing for on-street parking in the neighborhood adjacent to the Princeton High School/Westminster Choir College primarily attributable to the parking of students in this area. The mayor and council have therefore determined that the greater public interest will be served by insuring convenient and reasonable access to homes, businesses, the High School and the Westminster Choir College in this neighborhood and that the following limitations on parking will promote such an interest. Although this ordinance will allow some limited permitted parking for students, the mayor and council strongly believe that all students should avail themselves of public transportation, bicycling, car pooling and other modes of transportation whenever possible.

(b) Designation of residential permit parking areas.

From September 1 to June 30 of each year, excepting Saturdays, Sundays and legal holidays, parking on the streets or parts of streets below shall be prohibited, except to vehicles which display decals issued pursuant to this ordinance:

Section 5. The appropriate no parking signs shall be posted to implement this no parking regulation.

Section 6. This Ordinance shall take effect upon its passage and publication as required by law.

The purpose of this ordinance is to extend and or establish no parking zones on Hamilton Avenue, Moore Street, and Park Place in order to increase safety for motorists and residents by reducing or eliminating sight-line obstructions and restrictions on turning movements.
