

**AN ORDINANCE BY
PRINCETON CONCERNING
DESIGNATED BUS STOP
LOCATIONS ON BUNN DRIVE
AND AMENDING THE “CODE
OF THE BOROUGH OF
PRINCETON, NEW JERSEY,
1974”.**

WHEREAS, NJ Transit has received a request to establish additional bus stops on Bunn Drive to serve Princeton Professional Park; and

WHEREAS, New Jersey Transit has investigated the request and supports the establishment of additional stops to better serve patients who travel the 605 and 606 bus routes; and

WHEREAS, pursuant to N.J.S.A. 39:4-8(e), the former Borough of Princeton designated bus stop locations by ordinance;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of Princeton as follows:

Section 1. Section 19-12 (a) of the “Code of the Borough of Princeton, New Jersey 1974” (Code) designating bus stop locations is hereby amended as follows (additions are underlined; deletions are in [brackets]):

Sec. 19-12. Bus stops designated.

(a) Designated. The following areas upon the municipally controlled streets of Princeton are hereby designated as bus stops:

Bunn Drive, east side mid-block, beginning one thousand nine hundred eighty five feet (1,985’) south of the southerly curb line of Karl Light Boulevard and extending one hundred thirty five feet (135’) southerly therefrom.

Bunn Drive, west side mid-block, beginning one thousand nine hundred eighty feet (1,980’) south of the prolongation of the southerly curb line of Karl Light Boulevard and extending one hundred thirty five feet (135’) southerly therefrom (near the driveway to Princeton Professional Park).

Section 2. The appropriate bus stop signage will be posted by New Jersey Transit to implement the requirements of this ordinance.

Section 3. This ordinance shall take effect upon its passage and publication and approval of the Commissioner of Transportation as provided by law and shall become part of the new Princeton Code once completed and adopted.

Section 4. A certified copy of the approved ordinance shall be sent to New Jersey Transit.

The purpose of the ordinance is to address a request from New Jersey Transit to establish new bus stops along Bunn Drive. Pursuant to N.J.S.A. 39:4-8(e), a municipality has the authority to designate bus stops within its jurisdiction, subject to guidelines issued by the Commissioner of Transportation.

The foregoing ordinance was introduced at a meeting of the Mayor and Council of Princeton held on November 23, 2015 and will be further considered for final passage after a public hearing thereon at a meeting of said Mayor and Council to be held at the Princeton Municipal Complex, 400 Witherspoon Street on December 7, 2015 which begins at 7:00 p.m.
