

2016-18 AN ORDINANCE BY
PRINCETON REGULATING METERED
ON-STREET PARKING ZONES
PARKING ALONG PALMER SQUARE
SOUTH AND AMENDING THE “CODE
OF THE BOROUGH OF PRINCETON,
NEW JERSEY, 1974”

WHEREAS, in the current Code of the Borough of Princeton, metered on street parking on Palmer Square South, between Palmer Square West and Palmer Square East, is limited to thirty minutes parking; and

WHEREAS, the United Postal Services Palmer Square Branch is no longer operating at Palmer Square; and

WHEREAS, there is a desire to replace the existing thirty minute metered parking with two hour parking to better serve the parking patrons in this area.

NOW THEREFORE, BE IT ORDAINED by the Mayor and Council of Princeton as follows:

Section 1. Section 19-24(c)(1) and (d)(3) of the “Code of the Borough of Princeton, New Jersey 1974” (Code) establishing metered on-street parking zones, parking time limited to thirty minutes is hereby amended to read as follows (additions are underlined; deletions are in [brackets]):

Sec. 19-24. Metered on-street parking zones

(c) Parking time limited to thirty minutes.

(1) No person shall park a vehicle for longer than thirty minutes at any time between the hours of 8:00 A.M. and 8:00 P.M., Monday through Saturday and between the hours of 1:00 P.M. and 8:00 P.M., Sunday, upon any of the following streets or parts of streets:

[Palmer Square South, north side, from Palmer Square East to Palmer Square West.]

[Palmer Square South, south side from Palmer Square East, southerly section to Palmer Square East northerly section.]

(d) Parking time limited to two hours.

(3) Type two meters. No person shall park a vehicle for longer than two hours at any time between the hours of 8:00 A.M. and 7:00 P.M. Monday through Saturday, and between the hours of 1:00 P.M. and 8:00 P.M., Sunday, upon any of the following streets or parts of streets:

Palmer Square South, south side from Palmer Square East, southerly section to Palmer Square East northerly section.

Palmer Square South, south side from the southerly portion of Palmer Square West to the northerly portion of Palmer Square West.

Palmer Square South, north side, from Palmer Square East to Palmer Square West.

Section 2. The appropriate parking meter signs will be posted to implement the requirements of this Ordinance.

Section 3. This Ordinance shall take effect upon its passage and publication and shall become part of the new Princeton Code once completed and adopted.
