

Ordinance #2017-29

AN ORDINANCE BY THE MUNICIPALITY OF PRINCETON DESIGNATING BUS STOP LOCATIONS AND AMENDING THE “CODE OF THE BOROUGH OF PRINCETON, NEW JERSEY, 1974”.

WHEREAS, Section 19-12 of the “Code of the Borough of Princeton, New Jersey, 1974” (“Borough Code”) establishes the location of some, but not all, of the bus stops in the former Borough of Princeton and in the former Township of Princeton and is therefore incomplete; and

WHEREAS, the Princeton Council wishes to amend the Borough Code to establish the locations of all bus stops in the municipality.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of Princeton as follows:

Section 1. Pursuant to N.J.S.A. 39:4-8(e), section 19-12 of the “Code of the Borough of Princeton, New Jersey 1974,” which establishes bus stop locations in the municipality of Princeton, is hereby repealed in its entirety and shall be replaced with the following:

Sec. 19-12. Bus stops designated.

(a) Designated. The following areas upon the municipally controlled streets of Princeton are hereby designated as bus stops:

- (1) Along Alexander Street, northbound, on the easterly side thereof at:
 - a. Basin Street - (near side)
Beginning at prolongation of the southerly curblineline of Basin Street and extending 100 feet southerly therefrom (location 22553).
 - b. Between Faculty Road and University Place - (mid-block)
Beginning 135 feet north of the northerly curblineline of Faculty

Road and extending 93 feet northerly therefrom (location 22554).

- (2) Along Alexander Street, southbound, on the westerly side thereof at:
 - a. Between Faculty Road and University Place - (mid-block) (prolongation)
Beginning 157 feet north of the prolongation of the northerly curblineline of Faculty Road and extending 98 feet northerly therefrom (location 22555).
 - b. Basin Street - (far side)
Beginning at the southerly curblineline of Basin Street and extending 100 feet southerly therefrom (location 22556).
- (3) Along Billie Ellis Lane, southbound, on the westerly side thereof at:
 - a. Cherry Valley Road - (far side)
Beginning at the southerly curblineline of Cherry Valley Road and extending 142 feet southerly therefrom (location 31141).
- (4) Along Bunn Drive, northbound, on the easterly side thereof at:
 - a. Between Harrison Street North and Karl Light Boulevard - (mid-block)
Beginning 172 feet north of the northerly curblineline of Harrison Street North and extending 100 feet northerly therefrom (location 22580).
 - b. Between Harrison Street North and Karl Light Boulevard - (mid-block)
Beginning 1090 feet north of the northerly curblineline of Harrison Street North and extending 105 feet northerly therefrom (across from Princeton Professional Park) (location 32401).
- (5) Along Bunn Drive, southbound, on the westerly side thereof at:
 - a. Karl Light Boulevard - (near side)
Beginning at the extended centerline of Karl Light Boulevard and extending 105 feet northerly therefrom (location 22557).
 - b. Between Karl Light Boulevard and Harrison Street North- (mid-block)
Beginning 1181 feet north of the northerly curblineline of Harrison Street North and extending 105 feet southerly therefrom (Location 32402).
 - c. Between Karl Light Boulevard and Harrison Street North- (mid-block)

Beginning 423 feet north of northerly curbline of Harrison Street North and extending 105 feet northerly therefrom (Location 30171).

- (6) Along Ewing Street, northbound, on the easterly side thereof at:
 - a. Mount Lucas Road - (near side)
Beginning at the southerly curbline of Mount Lucas Road and extending 134 feet southerly therefrom (location 22546).
- (7) Along Ewing Street, southbound, on the westerly side thereof at:
 - a. Mount Lucas Road - (near side)
Beginning at the southerly curbline of Mount Lucas Road and extending 105 feet northerly therefrom (location 22547).
- (8) Along Griggs Drive, northbound, on the easterly side thereof at:
 - a. William Livingston Court - (far side)
Beginning at the northerly curbline of William Livingston Court and extending 85 feet northerly therefrom (location 22570).
- (9) Along Griggs Drive, southbound, on the westerly side thereof at:
 - a. Between David Brearly Court and William Patterson Court - (mid-block)
Beginning 66 feet north of the extended curbline of William Livingston Court and extending 85 feet northerly therefrom (location 30495).
- (10) Along Harrison Street North, northbound, on the easterly side thereof at:
 - a. Nassau Street - (far side)
Beginning 130' north of the northerly curbline of Nassau Street and extending 85 feet northerly therefrom (location 22512).
 - b. Mershon Drive- (far side)
Beginning at the northerly curbline of Mershon Drive and extending 123 feet northerly therefrom (location 22513).
 - c. Hornor Lane- (near side)
Beginning at the southerly curbline of Hornor Lane and extending 85 feet southerly therefrom (location 22514).
 - d. Franklin Avenue - (far side)
Beginning at the northerly curbline of Franklin Avenue and extending 85 feet northerly therefrom (location 22548).
 - e. Clearview Avenue - (near side)

Beginning at the southerly curbline of Clearview Avenue and extending 105 feet southerly therefrom (location 22549).

(11) Along Harrison Street North, southbound, on the westerly side thereof at:

- a. Clearview Avenue - (near side)
Beginning 12' south of the extended northerly curbline of Clearview Avenue and extending 70 feet northerly therefrom (location 22551).
- b. Franklin Avenue - (near side)
Beginning at the northerly curbline of Franklin Avenue and extending 102 feet northerly therefrom (location 22552).
- c. Ewing Street - (near side)
Beginning at the northerly curbline of Ewing Street and extending 105 feet northerly therefrom (location 22510).
- d. Spruce Circle - (far side)
Beginning at the southerly curbline of Spruce Circle and extending 184 feet southerly therefrom (location 22511).

(12) Along Karl Light Boulevard, northbound, on the easterly side thereof at:

- a. Mulberry Row - (near side)
Beginning at the southerly curbline of Mulberry Row and extending 105 feet southerly therefrom (location 30377).
- b. Butternut Row - (near side)
Beginning 115 feet east of the easterly curbline of Bunn Drive and extending 90 feet easterly therefrom (location 30378).

(13) Along Mount Lucas Road, southbound, on the westerly side thereof at:

- a. Between Ewing Street and Redding Circle - (mid-block)
Beginning 195 feet north of the northerly curbline of Ewing Street and extending 135 feet northerly therefrom (location 22558).

(14) Along Redding Circle, northbound, on the easterly side thereof at:

- a. Redding Circle North - (far side)
Beginning westerly curbline of Redding Circle North and extending 77 feet westerly therefrom (location 30328).
- b. Mount Lucas Road - (near side)
Beginning at the westerly curbline of Mount Lucas Road and extending 105 feet westerly therefrom (location 22571).

- (15) Along Sassafras Row, westbound, on the northerly side thereof at:
- a. Holly House Cul-De-Sac - (near side)
Beginning at the easterly curbline of Holly House Cul-De-Sac and extending 70 feet easterly therefrom (location 30379).
- (16) Along Terhune Road, eastbound, on the southerly side thereof at:
- a. Jefferson Road - (far side)
Beginning at the easterly curbline of Jefferson Road and extending 103 feet easterly therefrom (location 22559).
 - b. Walnut Lane - (near side)
Beginning at the westerly curbline of Walnut Lane and extending 105 feet westerly therefrom (location 22560).
- (17) Along Terhune Road, westbound, on the northerly side thereof at:
- a. North Harrison Street - (far side)
Beginning at the westerly curbline of North Harrison Street and extending 166 feet westerly therefrom (location 22561).
 - b. Walnut Street - (near side)
Beginning at the easterly curbline of Walnut Street and extending 105 feet easterly therefrom (location 22562).
 - c. Jefferson Road - (near side)
Beginning at the westerly curbline of Jefferson Road and extending 100 feet westerly therefrom (location 22563).
- (18) Along University Place, northbound, on the easterly side thereof at:
- a. Edwards Place - (near side)
Beginning 50' north of the prolongation of the northerly curbline of Edwards Place and extending 155 feet southerly therefrom (location 22517).
- (19) Along University Place, southbound, on the westerly side thereof at:
- a. Edwards Place - (near side)
Beginning at the northerly curbline of Edwards Place and extending 105 feet northerly therefrom (location 22515).
- (20) Along Witherspoon Street, northbound, on the easterly side thereof at:
- a. Between Hullfish Street and Wiggins Street - (mid-block)
Beginning 30 feet north of the prolongation of northerly curbline of Hullfish Street extending 142 feet northerly therefrom (location 30511).
 - b. Green Street - (near side)

- Beginning at the southerly curblineline of Green Street and extending 105 feet southerly therefrom (location 22521).
 - c. Shirley Court - (far side)
Beginning at the northerly curblineline of Shirley Court and extending 77 feet northerly therefrom (location 22522).
 - d. Franklin Avenue - (far side)
Beginning at the northerly curblineline of Franklin Avenue and extending 102 feet northerly therefrom (location 32265).
 - e. Guyot Avenue - (near side)
Beginning at the southerly curblineline of Guyot Avenue and extending 105 feet southerly therefrom (location 22565).
 - f. Valley Road - (near side)
Beginning at the southerly curblineline of Valley Road and extending 89 feet southerly therefrom (location 22566).
- (21) Along Witherspoon Street, southbound, on the westerly side thereof at:
- a. Valley Road - (far side)
Beginning at southerly curblineline of Valley Road and extending 239 feet southerly therefrom (location 22567).
 - b. Guyot Avenue - (far side)
Beginning at the prolongation of the southerly curblineline of Guyot Avenue and extending 105 feet southerly therefrom (location 22568).
 - c. Henry Avenue - (near side)
Beginning at the prolongation of the northerly curblineline of Henry Avenue and extending 105 feet northerly therefrom (location 22569).
 - d. Clay Street - (far side)
Beginning at the southerly curblineline of Clay Street and extending 75 feet southerly therefrom (location 32454).
 - e. Maclean Street - (near side)
Beginning at the northerly curblineline of Maclean Street and extending 73 feet northerly therefrom (location 22519).
 - f. Green Street - (far side)
Beginning at the southerly curblineline of Green Street and extending 137 feet southerly therefrom (location 22520).


Section 2. The appropriate signs shall be posted to implement the requirements of this

Ordinance.

Section 3. All ordinances and resolutions or parts thereof inconsistent with this Ordinance are repealed.

Section 4. This Ordinance shall take effect upon its passage and publication and shall become part of the new Princeton Code once completed and adopted.

The foregoing ordinance was introduced at a meeting of the Mayor and Council of Princeton held on May 8, 2017 and will be further considered for final passage after a public hearing thereon at a meeting of said Mayor and Council to be held in the Main Meeting Room at the Princeton Municipal Complex, 400 Witherspoon Street on June 12, 2017 beginning at 7:00 p.m., and during the week prior and up to and including the date of such meeting, a copy of said ordinance shall be made available free of charge at the Clerk's Office to the members of the general public who shall request the same.
