**RESOLUTION 19-246**

**Resolution Approving the Purchase a Portable Generator for the use by Princeton Sewer Operating Committee and Department of Public Works from Foley Rents in the discounted price of \$39,827.00**

WHEREAS, Princeton desires to obtain a portable generator for use by the Princeton Sewer Operating Committee and Department of Public Works; and

WHEREAS, on July 17, 2019, Foley Rents provided a written proposal to Princeton for purposes of providing to Princeton one (1) new portable generator described as a 60kva CAT Portable Generator, Trailer Mounted, C3.4 Diesel Engine, Tier 4 Final (“Equipment”) at the discounted price of \$39,827.00; and

WHEREAS, Princeton has a need to acquire the Equipment without a “fair and open process” as defined by P.L. 2004, c.19, the “Local Unit Pay-to-Play Law” and in connection therewith, Foley Rents has completed and filed with Princeton the required Campaign Contributions Affidavit pursuant to N.J.S.A. 19:44A-20.8, Certification Regarding Political Contributions pursuant to N.J.S.A. 19:44A-20.26 and affidavit pursuant section 2-87 of the Princeton Code (collectively, the “Pay-to-Play Forms”); and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available to pay for said services in 04-215-16-023-089-302; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-6.1a., authorizes Princeton to award this agreement without public bidding on the basis that the value will not exceed the bid threshold; and

WHEREAS, additional quotes were not solicited because it was not practicable to do so.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Municipality of Princeton, County of Mercer, State of New Jersey, as follows:

1. The Mayor and Clerk are hereby authorized and directed to execute an agreement with Foley Rents to purchase one (1) new 60kva CAT Portable Generator, Trailer Mounted, C3.4 Diesel Engine, Tier 4 Final for \$39,827.00; and
2. The agreement is awarded without competitive bidding as permitted by law; and
3. A copy of this Resolution, the Pay-to-Play Forms and the agreement shall be placed on file in the Office of the Clerk.
