



RESOLUTION 19-304

Resolution Authorizing a Construction Contract in the Not to Exceed Amount of \$805,213.13 with Earle Asphalt Company for Improvements to Alexander Street and Mount Lucas Road

WHEREAS, Princeton has advertised for and received bids in accordance with the provisions of the New Jersey Local Public Contracts Law, *N.J.S.A. 40A:11-2 et seq.* for Improvements to Alexander Street and Mount Lucas Road; and

WHEREAS, in connection therewith, Princeton has received the following three (3) bids on October 1, 2019:

1. \$805,213.13 by Earle Asphalt Company, Farmingdale, New Jersey;
2. \$821,902.38 by Top Line Construction Corp., Somerville, New Jersey;
3. \$1,144,309.00 by Black Rock Enterprise Inc., Old Bridge, New Jersey; and

WHEREAS, in reviewing said bids, Princeton has determined that the lowest responsive and responsible bidder is Earle Asphalt Company of Farmingdale, New Jersey in the amount of \$805,213.13; and

WHEREAS, Princeton has appropriated sufficient funds for this project in capital accounts 04-215-15-007-076-341, 04-215-16-020-076-348, 04-215-17-037-076-326, 04-215-15-007-076-342 and 04-215-15-007-076-315, as certified by Sandra Webb, Chief Financial Officer; and

WHEREAS, Princeton wishes to award a contract to undertake and complete said work to the aforementioned lowest responsible bidder.

NOW, THEREFORE, BE IT RESOLVED by the Princeton Council and the

Municipality of Princeton as follows:

1. The Mayor and Municipal Clerk of Princeton are hereby authorized and directed to enter into an agreement with Earle Asphalt Company of Farmingdale, New Jersey for a sum not to exceed \$805,213.13 to undertake and complete Improvements to Alexander Street and Mount Lucas Road, all in accordance with the terms and conditions with the Bid Documents which are on file in the office of the Clerk.

2. A certified true copy of this Resolution shall be furnished upon its adoption to Earle Asphalt Company of Farmingdale, New Jersey.
