



## **RESOLUTION 19-309**

## Resolution Awarding a Contract to Sports and Golf Solutions, LLC for the Installation of a Playground Shade Canopy at Barbara Smoyer Park in the amount not to exceed of \$17,800.00

WHEREAS, the municipality of Princeton desires to retain the services of a contractor for the purposes of removing the existing six (6) post shade structure at Barbara Smoyer Park, whose address is 593 Snowden Ln in Princeton and installing a new four (4) post shade structure with 40'x50' canopy; and

WHEREAS, Princeton has received two (2) quote to undertake and complete said work; and

WHEREAS, Princeton has sought a 3<sup>rd</sup> quote but the contractor was deemed non-responsive; and

WHEREAS, Sports & Golf Solutions, LLC provided the low quote to Princeton for the desired services in the not to exceed amount of \$17,800; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available to pay for said services in 04-215-19-021-12-369 - \$3,057.00; 04-215-17-037-121-334 - \$7,460.83; 04-215-15-007-075-332 - \$3,960.33; 04-215-19-021-121-359 - \$360.00; 04-215-96-018-121-101 - \$955.14 and 04-215-16-020-075-340 - \$2,006.70; and

WHEREAS, this contract is award is exempt from public bidding pursuant to N.J.S.A 40A:11-3(a) and 40A:11-6.1(a) because the contract amount does not exceed the bid threshold; and

WHEREAS, Princeton wishes to award a contract to undertake and complete said work to the aforementioned contractor with lowest responsible quote; and

WHEREAS, Princeton has a need to acquire these services without a "fair and open process" as defined by P.L.2004, c.19, the "Local Unit Pay-to-Play Law" and in connection

therewith, Sports & Golf Solutions, LLC has completed and filed with Princeton the required Campaign Contributions Affidavit pursuant to N.J.S.A. 19:44A-20.8, Certification Regarding Political Contributions pursuant to N.J.S.A. 19:44A-20.26 and affidavit pursuant section 2-87 of the Princeton Code (collectively, the Pay-to-Play Forms").

NOW, THEREFORE, BE IT RESOLVED by the Princeton Council and the Municipality of Princeton as follows:

- The Mayor and Clerk of Princeton are hereby authorized and directed to enter into an agreement with Sports & Golf Solutions, LLC. of Verona, NJ to remove the existing six (6) post shade structure at Barbara Smoyer Park and install a new four (4) post structure with 40' x 50' shade canopy, and all related services in a manner consistent with this Resolution and the above "Whereas" clauses.
- 2. Sports & Golf Solutions, LLC shall be paid a fee not to exceed \$17,800.00.
- 3. A certified true copy of this Resolution shall be furnished upon its adoption to Sports & Golf Solutions, LLC of Verona, NJ.
