RESOLUTION 19-310

Resolution Authorizing the Amendment of Resolution 19-262 from Central Jersey Equipment, LLC to the John Deere Company, Using Middlesex County Educational Services Commission of New Jersey Contract #: ESCNJ 18/19-25, for a John Deere XUV825M Multi-purpose Maintenance Cart w/Snow Plow Attachment in the amount of \$25,899.35 for use by the Recreation Department

WHEREAS, Resolution 19-262 authorizing the purchase of John Deere XUV82M Multi-Purpose Maintenance Cart w/Snow Plow Attachment is being amended due to the fact that it was initially made out to Central Jersey Equipment, LLC, however Central Jersey Equipment is merely filling the order as the local dealership. The equipment is actually being purchased directly from the John Deere Company; and

WHEREAS, the Princeton Recreation Department wishes to purchase one (1) John Deere XUV825M Multi-Purpose vehicle w/ snow plow attachment for use by the Recreation Department Staff; and

WHEREAS, John Deere Company (2000 John Deere Run, Cary, NC 27513) offers this equipment through the Middlesex County Educational Services Commission of New Jersey, contract 18/19-25; and

WHEREAS, the Municipality of Princeton is a member of the Middlesex County Educational Services Commission cooperative; and

WHEREAS, the cost of a John Deere XUV825 multi-purpose cart w/ snow plow attachment is \$25,899.35; and

WHEREAS, the appropriate monies are provided in Capital Account # 04-215-19-021-121-365 and Capital Account # 04-215-18-007-121-336; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available to pay for said purchases.

NOW THEREFORE BE IT RESOLVED that the Mayor and Council of Princeton authorize the Administrator and staff to purchase the above described vehicle for use by the Recreation Department Staff in the total amount of \$25,889.35.
