



RESOLUTION 19-313

**Resolution Authorizing the Award of the Contract Known As
"Princeton Fall 2019 Ash Replacement Project" to Sunset Creations,
Inc., in the amount of \$11,270.00 (Manors of Fieldwood) and
\$11,320.00 (Campbell Woods)**

WHEREAS, the Municipality of Princeton has solicited bid proposals for tree replacements at various locations within the Municipality of Princeton for Fall 2019 Ash Replacement Project; and

WHEREAS, all bid proposals were opened on September 26, 2019; and

WHEREAS, Princeton received the following bids:

Sunset Creations, Inc., Belle Mead, New Jersey in the amount of \$11,270.00 (Manors of Fieldwood) and \$11,320.00 (Campbell Woods)

WHEREAS, it is the recommendation of the Municipal Arborist/Open Space Manager that the contract be awarded to Sunset Creations, Inc., 355 Route 601, Belle Mead, New Jersey 08502 as the lowest responsible bidder; and

WHEREAS, Princeton's Chief Financial Officer has certified that sufficient funds in the total amount of \$11,270.00 (Manors of Fieldwood) and \$11,320.00 (Campbell Woods) are available for this project as follows:


NOW, THEREFORE, BE IT RESOLVED by the Council of the Municipality of
