



RESOLUTION 19-314

**Resolution Authorizing the Award of the Contract Known as
"Princeton Fall 2019 Planting Project" to Sunset Creations, Inc., in
the amount not to exceed \$30,690.00**

WHEREAS, the Municipality of Princeton has solicited bid proposals for tree planting at various locations within the Municipality of Princeton for Fall 2019; and

WHEREAS, all bid proposals were opened on September 26, 2019; and

WHEREAS, Princeton received the following bids: Loud, Continuous or Excessive Noise and Amending Chapter 21

Sunset Creations, Inc., Belle Mead, New Jersey in the amount of \$30,690.00

WHEREAS, it is the recommendation of the Municipal Arborist/Open Space Manager that the contract be awarded to Sunset Creations, Inc., 355 Route 601, Belle Mead, New Jersey 08502 as the lowest responsible bidder; and

WHEREAS, Princeton's Chief Financial Officer has certified that sufficient funds in the total amount of \$30,690.00 are available for this project as follows:

NOW, THEREFORE, BE IT RESOLVED by the Council of the Municipality of Princeton, County of Mercer, State of New Jersey, as follows:



2. Sunset Creations, Inc., 355 Route 601, Belle Mead, New Jersey 08502 shall be paid \$30,690.00.
