**RESOLUTION 19-332**

**Resolution Authorizing Federal Aid Cost Reimbursement Agreement  
No. 19-DT-BLA-308 for the Project Entitled Pedestrian Upgrades to  
Two Harrison Street Traffic Signals (Construction) (Fed. Proj. No. TAP  
2239(300))**

WHEREAS, the Federal Highway Administration (FHWA), through the New Jersey Department of Transportation, Division of Local Aid and Economic Development (DOT), has authorized funding up to \$674,071.00 in project costs for purposes of reimbursing the Municipality of Princeton for constructing pedestrian upgrades to two Harrison Street traffic signals in Princeton, and more specifically, at the intersections of Harrison Street/Hamilton Avenue and Harrison Street/Franklin Avenue under the DOT's "Safe Routes to Schools" (SRTS), which is a statewide initiative to enable and encourage students to safely walk and bicycle to school; and

WHEREAS, at this time the DOT has presented Princeton with a "Federal Aid Agreement" for execution which sets forth the terms and conditions of the DOT and FHWA's reimbursement funding of these project costs.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Municipality of Princeton, County of Mercer, State of New Jersey, that the Mayor and Clerk are hereby authorized and directed to execute the Federal Aid Agreement with the New Jersey Department of Transportation, Division of Local Aid and Economic Development, which provides for reimbursing the Municipality of Princeton for up to \$674,071.00 in project costs for purposes of constructing pedestrian upgrades to two Harrison Street traffic signals in Princeton, under the DOT's Safe Routes to Schools.
