Resolution to Award a Contract to MidState Radios for the Fire Department Portable Radios in the amount \$94,909.71

WHEREAS, Princeton wishes to purchase 10 AXP6000 UHF R2 Mode 2.5 portable radios, 3 AXP8000 All Brand Portable Model 2.5 radios and 2 APX8500 Mobile radios from MidState Mobile Radio, 1681 South Olden Ave, Trenton, NJ 08610;

WHEREAS, MidState Mobile Radio, 1681 South Olden Ave, Trenton, NJ 08610 has been awarded the New Jersey State Contract #83909 for the 10 AXP6000 UHF R2 Mode 2.5 portable radios, 3 AXP8000 All Brand Portable Model 2.5 radios and 2 APX8500 Mobile radios and;

WHEREAS, the 10 AXP6000 UHF R2 Mode 2.5 portable radios costs \$56,504.00, and 3 AXP8000 All Brand Portable Model 2.5 radios cost \$23,580.45 and 2 APX8500 Mobile radios cost \$14,825.26 the State Contract number is 83909 and the appropriate monies are provided in the Capital Fund Budget for the Department of Emergency & Safety Services in the amount of \$94,909.71 and;

WHEREAS, the Chief Financial Officer has certified the availability of said funds in Ordinance 04-215-15-007-052-318, 04-215-16-020-052-321, 04-215-17-037-052-314, 04-215-19-021-052-311, 04-215-19-021-052-310 and 04-215-18-007-052-304
