



RESOLUTION 19-382

Resolution Authorizing the Award of a Construction Contract to James R. Ientile Inc. in the Not to Exceed Amount of \$199,999.00 for Drainage Improvements at 120 Winant Road

WHEREAS, Princeton has advertised for and received bids in accordance with the provisions of the New Jersey Local Public Contracts Law, *N.J.S.A. 40A:11-2 et seq.* for Drainage Improvements to 120 Winant Road, Princeton, New Jersey; and

WHEREAS, in connection therewith Princeton has received the following eight (8) bids on December 10, 2019:

1. \$199,999.00 by James R. Ientile, Inc., Marlboro, New Jersey;
2. \$205,915.00 by Capella Construction, Inc., Sicklerville, New Jersey;
3. \$222,793.00 by Landtek Construction LLC dba United Terrain Group, Princeton, New Jersey;
4. \$270,342.50 by Messercola Excavating, Plainfield, New Jersey;
5. \$322,180.00 by Seacoast Construction, Inc., East Brunswick, New Jersey;
6. \$324,690.00 by Salmon Bros., Inc., Netcong, New Jersey;
7. \$326,164.14 by Top Line Construction Corp., Somerville, New Jersey;
8. \$355,615.00 by CMS Construction, Inc., Plainfield, New Jersey; and

WHEREAS, in reviewing said bids, Princeton has determined that the lowest responsive and responsible bidder is James R. Ientile, Inc., of Marlboro, New Jersey in the amount of \$199,999.00; and

WHEREAS, Princeton has appropriated sufficient funds for this project in capital accounts 04-215-18-007-076-325 and 04-215-19-021-076-347, as certified by Sandra Webb, Chief Financial Officer; and

WHEREAS, Princeton wishes to award a contract to undertake and complete said work to the aforementioned lowest responsible bidder.


NOW, THEREFORE, BE IT RESOLVED by the Princeton Council and the Municipality of Princeton as follows:

Ientile, Inc., of Marlboro, New Jersey for a sum not to exceed \$199,999.00; to undertake and complete Drainage Improvements to 120 Winant Road, Princeton, New Jersey, all in accordance with the terms and conditions with the Bid Documents which are on file in the office of the Clerk.
