RESOLUTION 19-384

Resolution Authorizing a One-Year Extension of the Crosstown Transportation Contract with Greater Mercer Transportation Management Association for the Not to Exceed Amount of \$139,984.80 for 2020

WHEREAS, the Municipality of Princeton has determined the need for services in connection with Transportation Services for Crosstown (“Crosstown”); and

WHEREAS, on February 27, 2017, the Mayor and Council of Princeton approved, in Resolution 17-76, a twenty-two month contract with Greater Mercer Transportation Management Association (“GMTMA”) for the operation of the Transportation Services for Crosstown; and

WHEREAS, GMTMA has provided satisfactory service through the term of the current Crosstown contract; and

WHEREAS, it is recommended that GMTMA be awarded the second of two one-year contract extensions for Transportation Services for Crosstown at a not to exceed cost of \$139,984.80, which sum represents a unit price per ride of \$14.60 for up to 9,588 rides in 2020; and

WHEREAS, the Municipality’s Chief Financial Officer has certified that funds are available in account 01-201-27-331-298 for the purposes set forth herein.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Municipality of Princeton as follows:


1. The foregoing “Whereas” clauses are incorporated herein as if fully restated.
2. The contract extension with GMTMA is hereby awarded for 2020, subject to the availability

of funds, for a not to exceed amount of \$139,984.80.

3. The Mayor and Municipal Clerk are hereby authorized and directed to a contract on behalf of the Municipality.
4. Contract payments will be based on the actual quantity of rides that take place during the applicable contract term.
5. All remaining provisions of the Agreement between Princeton and Greater Mercer Transportation Management Associates not inconsistent herewith, shall remain the same.
6. A copy of this Resolution and the agreement shall be placed on file in the Office of the Clerk.
