RESOLUTION 19-385

Resolution Authorizing a One-Year Contract Extension with Stout's Charter Service, Inc. for the Operation and Maintenance of the freeB Community Shuttle Service from January 1, 2020 through December 31, 2020 in the Not to Exceed Amount of \$129,356.56

WHEREAS, the Municipality of Princeton determined the need for operation and maintenance services in connection with the freeB Community Shuttle for a one-year initial term and provisions for two one-year contract extensions; and

WHEREAS, Princeton advertised for and received bids in accordance with the provisions of the New Jersey Local Public Contracts Law, *N.J.S.A. 40A:11-2 et seq.* for said services; and

WHEREAS, by Resolution 17-409 and Resolution 18-397, Princeton Council awarded the initial one-year term and the first of two one-year contract extensions to Stout's Charter Service, Inc. of Trenton, New Jersey; and

WHEREAS, the one-year term contract term extension expires on December 31, 2019 and it is recommended that the second one-year contract extension be awarded to Stout's Charter Service, Inc. from January 1, 2020 through December 31, 2020 in the amount of \$129,356.56; and

WHEREAS, the Municipality's Chief Financial Officer has certified that funds are available for the purposes set forth herein from account 05-201-02-009-299.

NOW, THEREFORE, BE IT RESOLVED by the Princeton Council and the Municipality of Princeton as follows:

1. The Mayor and Municipal Clerk are hereby authorized and directed to enter into a

contract with Stout’s Charter Service, Inc., 20 Irven Street, Trenton, New Jersey 08638 (hereinafter referred to as "Contractor") for the Operation and Maintenance of the freeB Community Shuttle Service consistent with this Resolution and the above “Whereas” clauses.

2. Stout’s Charter Service shall be paid a fee not to exceed \$129,356.56 for the one-year term, expiring on December 31, 2020.
3. All remaining provisions of the Agreement between Princeton and Stout’s Charter Service not inconsistent herewith, shall remain the same.
4. A copy of this Resolution and the agreement shall be placed on file in the Office of the Clerk.
