



RESOLUTION 20-32

Resolution Authorizing a One-Year Contract Extension in the Not to Exceed Amount of \$96,525.00 to Edward H. Cray, Inc., for 2020 Traffic Signal Maintenance and Construction Services

WHEREAS, the Municipality of Princeton has determined the need for traffic signal maintenance and construction services for an initial fourteen term and provisions for two one-year contract extensions; and

WHEREAS, Princeton advertised for and received bids in accordance with the provisions of the New Jersey Local Public Contracts Law, *N.J.S.A. 40A:11-2 et seq.* for said services; and

WHEREAS, by Resolution 17-327 adopted on October 23, 2017, the Princeton Council awarded a fourteen-month services contract to Edward H. Cray, Inc. for the provision of Traffic Signal Electrical Maintenance and Construction Services for Princeton, expiring on December 31, 2018; and

WHEREAS, the Edward H. Cray, Inc. bid includes options to extend the contract for up to two one-year terms for 2019 and 2020; and

WHEREAS, by Resolution 18-398 adopted on December 12, 2018, the Princeton Council awarded a one-year extension for the services contract to Edward H. Cray, Inc. for the provision of Traffic Signal Electrical Maintenance and Construction Services for Princeton, expiring on December 31, 2019; and

WHEREAS, it is recommended that Princeton Council approve the 2020 extension of the contract in the amount of \$96,525.00 to allow the continuation of the sought-after services with Edward H. Cray, Inc.; and

WHEREAS, sufficient funds are available for this capital project bid award, as certified


by Sandra Webb, Chief Financial Officer, from capital accounts #04-215-007-076-327 and 04-215-007-076-326.

NOW, THEREFORE, BE IT RESOLVED by the Princeton Council and the Municipality of Princeton as follows:

1. The Mayor and Municipal Clerk are hereby authorized and directed to enter into a contract with Edward H. Cray, Inc. (hereinafter referred to as "Contractor") for traffic signal repair services consistent with this Resolution and the above "Whereas" clauses.
2. Edward H. Cray, Inc. shall be paid a fee not to exceed \$96,525.00 for the one year term, expiring on December 31, 2020.
3. All remaining provisions of the Agreement between Princeton and Edward H. Cray, Inc. not inconsistent herewith, shall remain the same.
