



**RESOLUTION 20-42**

**Resolution Amending 2019 Contract for Pediatrician Services with Dr. Anjali Sharma Increasing the Not to Exceed Amount to \$12,881 from \$12,000.**

**WHEREAS**, on December 17, 2018, Princeton entered into a professional services agreement (“PSA”) with Dr. Anjali Sharma, 1106 Surrey Lane, Yardley, Pennsylvania, 19067 (hereafter referred to as “Provider” to provide professional public health pediatrician services, as authorized by the Mayor and Council by resolution adopted December 17, 2018; and

**WHEREAS**, said PSA was for a not-to-exceed amount of \$12,000.00; and

**WHEREAS**, this amount was based on an initial estimate of the total number of hours required to be provided in 2019 in connection with providers annual public health services; and

**WHEREAS**, during the third and fourth quarters of 2019, Princeton began to see an unprecedented number of uninsured residents to the well-baby preventative clinic; and

**WHEREAS**, due to the need to provide additional preventative health services, provider was required to provide more hours than originally anticipated for the year; and

**WHEREAS**, it is therefore necessary to increase the PSA’s not-to-exceed amount by \$881 to compensate provider for the additional services provided in 2019, resulting in a final not-to-exceed amount of \$12,881.00; and

**WHEREAS**, the Chief Financial Officer has certified that sufficient funds are available to pay for said services out of the Health Department budget, Professional & Consultant-Other Services line item, Account No. 01-201-27-330-281.


**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of Princeton on this 13<sup>th</sup> day of January, 2020 as follows:

1. The additional costs for public health nursing services provided in 2019 pursuant to the December 17, 2018 Professional Services Agreement entered into between Dr. Anjali Sharma and Princeton are hereby approved.
2. This Resolution, when counter-signed by Dr. Anjali Sharma shall serve as an amendment to the original PSA, bringing the final not-to-exceed contract amount for the above-referenced public health nursing services to \$12,881.00.
3. A notice of this action shall be published in the Princeton Packet as

required by law within ten (10) days of its passage.
