



RESOLUTION 20-122

Resolution Authorizing Use of State Contract #A42270 (T-0849) with Independence Constructors in the Not to Exceed Amount of \$61,227.00 (TBD) for Removal of the Fuel Facility Canopy, Lighting Installation, Masonry Wall Construction and Other Associated Work

WHEREAS, N.J.S.A. 40A:11-12 provides that a contracting unit may, without advertising for bids, purchase any materials, supplies or equipment under any contract entered into on behalf of the State by the Division of Purchase and Property in the Department of Treasury; and,

WHEREAS, the municipality of Princeton has authorized purchases under the appropriate State Contract, and utilized the bidding advantage done by the State; and

WHEREAS, Independence Constructors, Inc., 1200 Route 22 East, Bridgewater, New Jersey 08807, has been awarded New Jersey State Contract #A42270 (T No.: T-0849) for installation, removal, and repair to aboveground fuel tanks; and

WHEREAS, Independence Constructors, Inc. has provided a quote of \$61,227.00 for the demolition of the canopy, installation of new lighting, extensions to the masonry walls, and other accessory work as detailed in its March 3, 2020 quote; and

WHEREAS, the Engineering Department recommends encumbering \$61,227.00 for said work; and

WHEREAS, the Chief Financial Officer has certified that there are sufficient funds available in account 01-201-20-111-283 for this contract.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of Princeton, County of Mercer, State of New Jersey, as follows:


1. The Chief Financial Officer is authorized to encumber \$61,227.00 for the services
