RESOLUTION 20-157

Resolution Authorizing a Professional Services Agreement in the amount of \$8,918.82 with WSP USA for Construction Support Services Related to the Safe Routes to School Project Entitled "Pedestrian Improvements to Two Traffic Signals on Harrison Street", Reimbursable Through the Project's Federal Aid Agreement

WHEREAS, the Municipality of Princeton desires to obtain professional construction support services for the federally-funded project entitled "Pedestrian Upgrades to Two Harrison Street Traffic Signals (Federal Project No.: TAP-2239(300)); and

WHEREAS, WSP USA provided a proposal dated March 9, 2016 for preliminary engineering, final engineering, and construction support services in the amount of \$123,825.79; and

WHEREAS, in Resolutions 16-145 and 17-174, the Municipality of Princeton authorized professional services agreements with WSP for preliminary and final engineering services in the total amount of \$114,906.97; and

WHEREAS, the Pedestrian Upgrades to Two Harrison Street Traffic Signals project is in the preconstruction phase; and

WHEREAS, the Princeton Engineering Department now requires construction support services for this project by WSP USA in accordance with the proposal dated March 9, 2016 at a cost of \$8,918.82; and

WHEREAS, the New Jersey Department of Transportation advised in an email on February 24, 2020 that additional federal funds will be allocated to the Municipality of Princeton's project to cover the cost of these construction support services on a reimbursable basis; and


WHEREAS, the Chief Financial Officer has certified that sufficient funds are available in capital account 04-215-15-007-076-340 to pay for said services; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the Municipality of Princeton, County of Mercer, State of New Jersey, as follows:

1. The Mayor and Clerk are hereby authorized and directed to execute an agreement with WSP USA for professional construction management and construction inspection services, consistent with this Resolution and the above "Whereas" clauses.
2. WSP USA shall be paid a fee not to exceed \$8,918.82.
3. The term of the contract shall be one year.
4. A copy of this Resolution and the agreement shall be placed on file in the Office of the Clerk.
5. A notice of this action shall be published in the official newspaper as required by law.
