



RESOLUTION 20-339

Resolution by the Municipality of Princeton Requesting the Modification of the New Jersey Department of Transportation Traffic Regulations for "No Parking Taxi Zone" and "Time Limit Parking" on New Jersey State Route 27 (Nassau Street) Between Elm Drive and Witherspoon Street in the Northbound Direction

WHEREAS, the licensure of taxi cabs in the Municipality of Princeton has been decreasing over the last five years; and

WHEREAS, the Municipality of Princeton is seeking to remove the existing traffic regulations for a taxi stand on Nassau Street (NJ State Highway Route 27) near Witherspoon Street in the northbound direction (easterly side) immediately upon approval by the Commissioner of Transportation; and

WHEREAS, the Municipality of Princeton has submitted a Resolution of Concurrence to the New Jersey Department of Transportation to relocate the existing New Jersey Transit bus stop on the near side of the Nassau Street (NJ State Route 27) intersection with Witherspoon Street in the northbound direction (easterly side); and

WHEREAS, the Municipality of Princeton seeks to establish time limit parking in the locations vacated by the removal of the bus stop and the taxi stand immediately upon approval by the Commissioner of Transportation; and

WHEREAS, the Traffic Safety Committee has no objection to establishing additional on-street parking in these locations.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of Princeton, County of Mercer, State of New Jersey that, pursuant to N.J.S.A. 39-4-8(e), hereby approve the

following modification to the Commissioner of Transportation's Traffic Regulation Order for New Jersey State Route 27, and specifically the addition of "time limit parking" (*additions shown as underlined, deletions shown with a strikethrough*):

(e) The certain parts of State Highway Route NJ 27 described in this subsection are hereby designated and established as "time limit parking" zones where parking is permitted as described:

1. In Mercer County:

i. In the Municipality of Princeton:

(1) Three ~~Two~~ hour (~~32~~) time limit parking (metered) between ~~9~~8:00 AM and 8:00 PM Monday through Thursday, 9:00 AM and 9:00 PM Friday and Saturday, and 1:00 PM and 8:00 PM Sunday along the northbound (easterly) side, ~~except Sundays:~~

(A) Between the northerly curb line of University Place and the prolongation of the southerly curb line of Chambers Street.

(B) Between the prolongation of the northerly curb line of Chambers Street and the prolongation of the southerly curb line of John Street.

(C) Between the northerly curb line of Elm Drive and the prolongation of the southerly curb line of Witherspoon Street.

(D) Between the prolongation of the northerly curb line of Witherspoon Street and the prolongation of the southerly curb line of Tulane Street.

(E) Between a point 100 feet north of the prolongation of the northerly curb line of South

Tulane Street and the prolongation of the southerly curb line of Vandeventer Avenue.

~~(2) — Two (2) hour time limit parking (metered) between 8:00 AM and 7:00 PM along the northbound (easterly) side, except Sundays:~~

(FA) Between the northerly curb line of Mercer Street and the southerly curb line of University Place.

(GB) Between the northerly curb line of Washington Road and a point 410 feet northerly therefrom.

(HC) Between a point 470 feet north of the northerly curb line of Washington Road and the prolongation of the southerly curb line of Moore Street.

(ID) Between the northerly curb line of Charlton Street and the prolongation of the southerly curb line of Moran Avenue.

(JE) Between the prolongation of the northerly curb line of Chestnut Street and the prolongation of the southerly curb line of Pine Street.

BE IT FURTHER RESOLVED, by the Mayor and Council of Princeton, County of Mercer, State of New Jersey that, pursuant to N.J.S.A. 39-4-8(e):

1. The Mayor and Council hereby approve the following modification to the Commissioner of Transportation's Traffic Regulation Order for New Jersey State Route 27, and specifically removal of the current the "no parking taxi stand" regulation:

~~(f) — The certain parts of State Highway Route NJ 27 described in this subsection shall be designated and established as "no parking taxi stand" zones where parking is~~

~~prohibited at all times, except for approved taxis:~~

~~1. In Mercer County:~~

~~i. In the Municipality of Princeton:~~

~~(1) No parking (taxi stand) along the northbound (easterly) side:~~

~~(A) Between a point 98 feet north of the prolongation of the northerly curb line of Palmer Square East and a point 76 feet northerly therefrom.~~

2. The Mayor and Council formally request that the removal of the taxi stand take effect upon approval by the Commissioner of Transportation.

3. The Mayor and Council formally request that the modification to time limit parking take effect upon approval by the Commissioner of Transportation as provided by law.

4. The Mayor and Council formally request that the Commissioner of Transportation make the foregoing modifications to the above referenced text of the applicable Traffic Regulation Order for New Jersey State Route 27.


5. A certified copy of this Resolution shall be transmitted by the Municipal Clerk to the Commissioner of Transportation within 30 days of its adoption.

6. The Municipality of Princeton shall enforce the Traffic Regulation Order governing the aforementioned time limited parking.

7. The Municipality of Princeton shall install and maintain white pavement markings, meter equipment, and parking signage associated with the new time limited parking.
