**Resolution Authorizing Grant Agreement Green Acres Program for
Open Space Acquisition**

ENABLING RESOLUTION

WHEREAS, the New Jersey Department of Environmental Protection, Green Acres Program ("State"), provides loans and/or grants to municipal and county governments and grants to nonprofit organizations for assistance in the acquisition and development of lands for outdoor recreation and conservation purposes; and

WHEREAS, the Municipality of Princeton has previously obtained a grant of \$6,000,500.00 from the State to fund the following project(s):

#1110-00-054 - Princeton Open Space Acquisition; and

WHEREAS, the State and the Municipality of Princeton intend to increase Green Acres funding by \$125,000.00; and

WHEREAS, the applicant is willing to use the State's funds in accordance with its rules, regulations and applicable statutes, and is willing to enter into an Amendment of the Agreement with the State for the above-named project;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE MUNICIPALITY OF PRINCETON IN THE COUNTY OF MERCER AND STATE OF NEW JERSEY THAT:

1. The Marc D Dashfield, Municipal Administrator of the above named body or board is hereby authorized to execute an agreement and any amendment thereto with the State known as Princeton Open Space Acquisition, and;
2. The applicant has its matching share of the project, if a match is required, in the amount of \$6,125,500.00.
3. In the event the State's funds are less than the total project cost specified above, the applicant has the balance of funding necessary to complete the project, and;

The applicant agrees to comply with all applicable federal, state, and local laws, rules, and regulations in its performance of the project.

This resolution shall take effect immediately.
