**Resolution Authorizing a Contract in the Not to Exceed Amount of \$80,300.00 for a Twelve Month Term to Greater Mercer Transportation Management Association (GMTMA) for Crosstown Transportation Services**

**WHEREAS**, the Municipality of Princeton has determined the need for Transportation Services for Crosstown in 2021; and

**WHEREAS**, the Municipality solicited bid proposals and publicly opened and read the following two bids received on December 16, 2020:

1. Greater Mercer Transportation Management Association, Princeton, New Jersey - \$80,300.00 for 2021, \$109,900.00 for 2022, and \$106,200.00 for 2023;
2. Mercy Transportation Inc., Monmouth Junction, New Jersey - \$137,500.00 for 2021, \$196,000.00 for 2022, and \$216,000.00; and

**WHEREAS**, Greater Mercer Transportation Management Association, Inc. has previously provided the Crosstown Transportation Services in a satisfactory manner; and

**WHEREAS**, it is the recommendation of the Municipal Engineer that the Greater Mercer Transportation Management Association, Inc., Inc. contract be awarded for an initial twelve-month service period of January 1, 2021 through December 31, 2021, utilizing Bid Item for Rides in 2021 at \$14.60 per ride, which results in a total annual contract amount of \$80,300.00; and


**WHEREAS**, the Municipality's Chief Financial Officer has certified that funds are available in account 01-201-27-331-298 for the purposes set forth herein.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Municipality of Princeton as follows:

1. The foregoing “Whereas” clauses are incorporated herein as if fully restated.
2. The contract between Princeton and Greater Mercer Transportation Management Association, Inc. of 15 Roszel Road, Princeton, N.J. 08540 is hereby authorized for an initial twelve-month term, subject to the terms and conditions set forth in the contract documents. Two one-year extensions for 2022 and 2023 may be authorized by separate Council actions in subsequent years.
3. The value of the contract shall be \$80,300.00, as set forth in the attached bid tabulation, as recommended by the Municipal Engineer.
4. The Mayor and Municipal Clerk are hereby authorized and directed to execute an amendment to the original contract on behalf of the Municipality.
