



RESOLUTION 21-115

Resolution Authorizing a Professional Services Agreement with Leckington Advisors LLC for Preparation of the 2021 CDBG Grant Application in the Not to Exceed Amount of \$14,500.00

WHEREAS, the Municipality of Princeton has received a grant agreement from the U.S. Department of Housing & Urban Development for a 2020 Community Development Block Grant (CDBG) Entitlement Community in the amount of \$242,948.0; and

WHEREAS, Princeton also received an additional CBDG grant agreement in the amount of \$333,924.00 in response to the COVID-19 pandemic; and

WHEREAS, Princeton is slated to receive \$225,797.00 for Program Year 2021 as additional CDBG grant; and

WHEREAS, Princeton wishes to retain Leckington Advisors LLC as a Consultant to provide ongoing support for the Administration of the CDBG Grant for program year 2020 and to also prepare the 2021 Annual Action Plan; and

WHEREAS, the cost of the services to be provided by Leckington Advisors LLC are eligible for reimbursement directly from the CDBG Grant.


NOW THEREFORE, BE IT RESOLVED by the Princeton Council as follows:

The Mayor and Clerk are hereby authorized and directed to enter into an agreement with Leckington Advisors LLC, 105 Caldwell Drive, Trenton, New Jersey 08618 for a sum not to exceed \$14,500 to provide ongoing support for the Administration of the above-referenced CDBG Grants and to prepare the 2021 Annual Action Plan. The Agreement authorized by this Resolution is on file in the Office of the Municipal Clerk and may be inspected during regular office hours.
