



**RESOLUTION 21-258**

**Release of Maintenance Bond No. 015205053 in the Amount of \$54,155.44 to S. Brothers, Inc. for the 2018 Roadway Resurfacing Project, Contingent Upon the Completion of Bituminous Pavement Joint Cleaning and Sealing at Various Locations**

WHEREAS, pursuant to duly advertised Notice to Bidders in accordance with the New Jersey Public Contracts Law, *N.J.S.A.* 40A:11-1 et seq., bids were received and a construction contract awarded to S. Brothers, Inc. for the 2018 Roadway Resurfacing for a contract amount of five hundred eighty-two thousand four hundred eighty-nine and sixty-five cents (\$582,489.65); and

WHEREAS, by Resolution 19-96, Princeton Council authorized a final change order and release of the Performance Bond for the project, contingent about receipt of an acceptable Maintenance Bond in the amount of \$54,155.44; and

WHEREAS, the Engineering Department has completed a final maintenance inspection and recommends the release of the Maintenance Bond, contingent upon the completion of bituminous pavement joint cleaning and sealing with hot rubberized joint sealer at the following locations:

1. Bituminous pavement center joint on Mountain Avenue from Quarry Lane to Morgan Place;
2. Bituminous pavement center joint on Moore Street from Guyot Avenue to Henry Avenue;
3. Bituminous pavement lateral joints and end joints on Great Road at the following locations: Section 1 at Pretty Brook Road, Section 2 at Farmview Fields, Section 3 at Princeton Day School, and Section 4 between Great Road West and Cherry Valley Road.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of Princeton hereby approves the release of the maintenance bond in the amount of \$54,155.44 for the 2018 Roadway Resurfacing.

**WHEREAS**, the Engineering Department performed a final inspection and recommends the release of the Maintenance Bond No. 015205053(M), contingent upon the pavement repair work listed above.
