



RESOLUTION 21-280

Resolution Awarding a Construction Contract to Earle Asphalt Company in the Not to Exceed Amount of \$1,485,413.13 for the 2021 Roadway Resurfacing Contract

WHEREAS, in response to a duly advertised Notice to Bidders under the New Jersey Local Public Contracts Law, *N.J.S.A. 40A:11- 1 et seq.*, on August 12, 2021, Princeton received the following seven (7) bids for the Roadway Resurfacing 2021 Project:

1. Earle Asphalt Company of Farmingdale, New Jersey - \$1,485,413.13
2. Top Line Construction Corp. of Somerville, New Jersey - \$1,521,519.54
3. Capital Paving & Contracting of Lebanon, New Jersey - \$1,542,137.82
4. MECO, Inc. of Clarksburg, New Jersey - \$1,549,492.13
5. Black Rock Enterprises, LLC of Old Bridge, New Jersey - \$1,825,000.00
6. Pave-Rite, Inc. of Bridgewater, New Jersey - \$1,931,459.18
7. S. Brothers Inc. of South River, New Jersey - \$1,947,871.07; and

WHEREAS, the Engineer has reviewed Earle Asphalt Company's bid and recommends that the contract be awarded to Earle Asphalt Company as the lowest responsible bidder; and

WHEREAS, the Municipal Attorney's Office has reviewed the bid submitted by Earle Asphalt Company and finds that its submission is in compliance with the bidding requirements for same; and

WHEREAS, Princeton has appropriated sufficient funds for this project in capital account 04-215-19-021-076-353 as certified by Sandra Webb, Chief Financial Officer; and

WHEREAS, Princeton wishes to award a contract to undertake and complete said work to the aforementioned lowest responsible bidder.


NOW, THEREFORE, BE IT RESOLVED by the Princeton Council in the Municipality of Princeton as follows:

1. The Mayor and Clerk are hereby authorized and directed to enter into an agreement with Earle Asphalt Company for a sum not to exceed \$1,485,413.13 to undertake and complete the Roadway Resurfacing 2021 Project, all in accordance with the terms and conditions with the Bid Documents which are on file in the office of the Clerk.
