**RESOLUTION 21-296**

**Resolution Awarding a Contract in the Not to Exceed Amount of \$77,975.00 with Straight Edge Striping for the 2021 Pavement Striping and Markings Contract**

**WHEREAS**, Princeton has advertised for and received bids in accordance with the provisions of the New Jersey Local Public Contracts Law, *N.J.S.A. 40A:11-2 et seq.* for Traffic Striping and Pavement Marking Contract; and

**WHEREAS**, in connection therewith Princeton has received the following four (4) bids on September 9, 2021:

1. \$77,975.00 by Straight Edge Striping of Middlesex, New Jersey;
2. \$78,175.00 by Dan Swayze & Son, Inc. of Scotch Plains, New Jersey;
3. \$97,753.00 by Traffic Lines, Inc. of Farmingdale, New Jersey;
4. \$109,762.50 by Denville Line Painting, Inc. of Rockaway, New Jersey; and

**WHEREAS**, in reviewing said bids, Princeton has determined that the lowest responsive and responsible bidder is Straight Edge Striping of Middlesex, New Jersey in the amount of \$77,975.00; and

**WHEREAS**, Princeton has appropriated sufficient funds for this project in capital accounts 04-215-21-021-076-330 (\$50,000.00), 04-215-19-021-076-346 (\$21,566.04), and 04-215-18-007-076-326 (\$6,408.96), as certified by Sandra Webb, Chief Financial Officer; and

**WHEREAS**, Princeton wishes to award a contract to undertake and complete said work to the aforementioned lowest responsible bidder for the contract term of 2021-2022; and


**NOW, THEREFORE, BE IT RESOLVED** by the Princeton Council and the Municipality of Princeton as follows:

1. The Mayor and Deputy Municipal Clerk of Princeton are hereby authorized and directed to enter into an agreement with Straight Edge Striping of Middlesex, New Jersey for a sum not to exceed \$77,975.00; to undertake and complete the Traffic Striping and Pavement Marking Contract, all in accordance with the terms and conditions with the Bid Documents which are on file in the office of the Clerk.

2. A certified true copy of this Resolution shall be furnished upon its adoption to Straight Edge Striping of Middlesex, New Jersey.
