Resolution Authorizing the Award of a Contract to Deere & Company, Educational Services Commission of New Jersey Contract #ESCNJ 18/19-25, for a John Deere 1575 TerrainCut with ComfortCab Commercial Front Mower in the Amount of \$34,046.31 and John Deere 72 inch 7-Iron Pro Commercial Side Discharge Mower Deck in the Amount of \$4,125.42 for use by the Recreation Department

WHEREAS, the Princeton Recreation Department wishes to purchase one (1) John Deere 1575 TerrainCut with ComfortCab Commercial Front Mower; and

WHEREAS, the Princeton Recreation Department wishes to purchase one (1) John Deere 72 inch 7-Iron PRO Commercial Side Discharge Mower Deck; and

WHEREAS, Deere & Company through their local dealer Central Jersey Equipment, LLC has been awarded the Educational Services Commission of New Jersey contract #ESCNJ 18/19-25 for John Deere equipment; and

WHEREAS, the Municipality of Princeton is a member of the Educational Services Commission of New Jersey (formerly Middlesex County Educational Services Commission of New Jersey); and

WHEREAS, the cost of a John Deere 1575 TerrainCut with ComfortCab Commercial Front Mower is \$34,046.31; and

WHEREAS, the cost of a John Deere 72 inch 7-Iron PRO Commercial Side Discharge Mower Deck is \$4,125.42; and

WHEREAS, the appropriate monies are provided in Capital Account # 04-215-13-021-121-346; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available to pay for said purchases.

NOW THEREFORE BE IT RESOLVED that the Mayor and Council of Princeton authorize the Administrator and staff to purchase the above described equipment for use by the Recreation Department Staff under Educational Services Commission of New Jersey Contract #ECSNJ 18/19-25 in the total amount of \$38,171.73.
