**RESOLUTION 21-308**

**Resolution Authorizing Early Termination of Agreement with Transloc, Inc.**

**WHEREAS**, on about February 27, 2017, Princeton entered into a five (5) year agreement to license a proprietary vehicle tracking and passenger information service from TransLoc, Inc. for use in the management, location and inventory of Princeton's two (2) Free B vehicles, and integration of said services with Princeton University's "Tiger Transit" system, for the not to exceed contract amount of \$22,000.00 ("Agreement"); and

**WHEREAS**, in 2020, Princeton was forced to suspend the Free B services due to the COVID-19 pandemic; and

**WHEREAS**, in August 2021, Princeton resumed its free public transit services for the community, but through a different vendor and program, based in part on the decision that it was no longer feasible or economical for Princeton to operate the Free B shuttle service for the foreseeable future; and

**WHEREAS**, as a result of indefinite suspension of the Free B program, Princeton does not have a need for the services provided by TransLoc, Inc., although the Agreement would not expire until March 2022; and

**WHEREAS**, Princeton has paid TransLoc, Inc. approximately \$16,454.84 through early 2020 for the services; and

**WHEREAS**, Princeton and TransLoc, Inc. have agreed to terminate the five (5) year Agreement early in consideration of payment of a portion of the remaining amount under the Agreement to TransLoc, Inc. of \$2,000.00; and

**WHEREAS**, the Chief Financial Officer has certified that sufficient funds are available to pay this amount to terminate the Agreement early.


**NOW THEREFORE BE IT RESOLVED** by the Mayor and Council of Princeton as follows:

1. In accordance with the “Whereas” clauses above, the Mayor and Clerk of Princeton are hereby authorized and directed to execute an Amendment to the original Agreement between Princeton and TransLoc., Inc. for termination of said Agreement for the convenience of the parties.

2. In accordance with the Amendment to the Agreement, Princeton shall remit payment of \$2,000.00 to TransLoc, Inc. in full satisfaction of its remaining obligations under the original Agreement.
