RESOLUTION 21-324

Resolution Authorizing the Award of a Contract to National Auto Fleet Group via the Sourcewell Contract for the Purchase of Two (2) 2022 Ford Super Duty F-250 Pick Up Trucks with Snow Plows for the SOC Department in the amount of \$95,921.52

WHEREAS, the Department of Infrastructure and Operations (“Department”) recommends that the Municipality of Princeton (“Princeton”) procure two (2) 2022 Ford Super Duty F-250 Pick Up Trucks with Snow Plows for the SOC Department; and

WHEREAS, the Department has researched vendors that would achieve the Department’s goals and determined that the sought-after Pick Up Trucks may be procured through a nationally-recognized and accepted cooperative purchasing contract in effect until August 1, 2024 between Sourcewell [formerly known as National Joint Powers Alliance (“NJPA”)] and National Auto Fleet Group; and

WHEREAS, Princeton is a member of the Sourcewell (Princeton Member ID # - 28187); and

WHEREAS, pursuant to N.J.S.A. 52:34-6.2b.(3) (as amended by P.L. 2011, c. 139) and LFN 2012-10, a New Jersey municipality may purchase goods and services without public bidding under the Local Public Contracts Law through the use of a nationally-recognized and accepted cooperative purchasing contract that has been developed utilizing a competitive bidding or contracting process by another contracting unit within New Jersey or another State; and

WHEREAS, Sourcewell is a regional organization of governmental units operating under the laws of the State of Minnesota and is itself a government corporation and agency pursuant to the laws of Minnesota; and

WHEREAS, the subject cooperative purchasing contract was awarded by then NJPA to National Auto Fleet Group utilizing a competitive contracting process; and

WHEREAS, also pursuant to N.J.S.A. 52:34-6.2b.(3) (as amended by P.L. 2011, c. 139) and LFN 2012-10, prior to making purchases under nationally-recognized and accepted cooperative purchasing contracts, the Municipality must determine that the use of the cooperative purchasing contract shall result in cost savings after all factors, including charges for service, material, and delivery have been considered; and

WHEREAS, the Department has determined that Princeton’s use of the Sourcewell cooperative purchasing contract to procure the sought-after two (2) 2022 Ford Super Duty F-250 Pick Up Trucks with Snow Plows for the SOC Department; and


WHEREAS, consistent with the Sourcewell cooperative purchasing contract and needs of Princeton, National Auto Fleet Group has submitted a proposal to provide the two (2) 2022 Ford Super Duty F-250 Pick Up Trucks with Snow Plows for the SOC Department for use by the Municipality of Princeton for the sum of \$95,921.52; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds in the amount of \$95,921.52 in account 04-215-21-019-089-309 (\$65,000.00) and 04-215-21-019-089-308 (\$30,921.52) are available for this purchase.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Municipality of Princeton, County of Mercer, State of New Jersey that a contract for the purchase of two (2) 2022 Ford Super Duty F-250 Pick Up Trucks with Snow Plows for the SOC Department for use by the Municipality of Princeton in the amount of \$95,921.52 is hereby awarded to National Auto Fleet Group without public bidding as permitted by law.
