**RESOLUTION 21-376**

**Resolution of the Mayor and Council of Princeton Authorizing a Two-Year Contract with Jen Electric Inc. in the amount of \$84,080.00 for Traffic Signal Electrical Maintenance Services**

**WHEREAS**, in response to a duly advertised Notice to Bidders under the New Jersey Local Public Contracts Law, *N.J.S.A. 40A:11- 1 et seq.*, on November 23, 2021, Princeton received the following two (2) bids for the Traffic Signal Electrical Services contract:

1. Jen Electric Inc. of Springfield, New Jersey - \$84,080.00
2. Edward H. Cray of Trenton, New Jersey - \$88,400.00

**WHEREAS**, the Engineer has reviewed Jen Electric's bid and recommends that the contract be awarded to Jen Electric Inc. as the lowest responsible bidder; and

**WHEREAS**, the Municipal Attorney's Office has reviewed the bid submitted by Jen Electric Inc. and finds that its submission is in compliance with the bidding requirements for same; and

**WHEREAS**, Princeton has appropriated sufficient funds for this project in capital accounts 04-215-18-007-076-327 (\$28,457.20), 04-215-19-021-076-349 (\$12,700.01), and 04-215-21-021-076-329 (\$42,922.79) as certified by Sandra Webb, Chief Financial Officer; and

**WHEREAS**, Princeton wishes to award a contract to undertake and complete said work to the aforementioned lowest responsible bidder.

**NOW, THEREFORE, BE IT RESOLVED** by the Princeton Council in the Municipality of Princeton as follows:

1. The Mayor and Clerk are hereby authorized and directed to enter into an agreement with Jen Electric Inc. for a sum not to exceed \$84,080.00 to undertake and complete the Traffic Signals Electrical Services contract, all in accordance with the terms and conditions with the Bid Documents which are on file in the office of the Clerk.

2. A certified true copy of this Resolution shall be furnished upon its adoption to Jen Electric Inc.
