



RESOLUTION 21-399

Resolution of the Mayor and Council of Princeton Amending 2021 Professional Services Agreement with Scarinci & Hollenbeck, LLC and Increasing Not to Exceed Amount by Additional \$60,000.00

WHEREAS, by Resolution 21-101 adopted on March 22, 2021, Princeton Council awarded a professional services agreement to Scarinci & Hollenbeck, LLC and John M. Scagnelli, Esq. for professional legal services to be rendered to Princeton in connection with various environmental issues at its facility located at 298 River Road, in an amount not to exceed \$50,000.00 (“Agreement”); and

WHEREAS, at this time the Chief Financial Officer requests and recommends that the contract amount for the 2021 services be increased by \$60,000.00, for a total not to exceed contract amount for 2021 services of \$110,00.00, to ensure the proper payment to said professional for additional work completed in connection with the professional legal services originally awarded pursuant to Resolution 21-101; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available to pay for said services from account 01-201-20-111-283.

NOW, THEREFORE, BE IT RESOLVED by the Council of Princeton, County of Mercer, State of New Jersey, as follows:

1. Based on the reasons set forth in the above “Whereas” clauses, the Professional Services Agreement with Scarinci & Hollenbeck LLC and John M. Scagnelli, Esq. for various environmental legal services to be rendered to Princeton awarded pursuant to Resolution 21-101 shall be amended by increasing the total not to

exceed contract amount to \$110,000.00 for 2021 services.






