Resolution of the Mayor and Council of Princeton Designating 2022 Schedule of Meetings for the Mayor and Council of Princeton

WHEREAS, N.J.S.A. 10:4-8 requires the adoption, posting and distribution of an Annual Notice of Meetings; and

WHEREAS, N.J.S.A. 10:4-8 requires that an Annual Notice of meetings be set at least once a year; and

WHEREAS, N.J.S.A. 10:4-8 requires that the Annual Notice to be delivered to two newspapers which have been designated by the Mayor and Council to receive such notices; and

WHEREAS, Closed Session meeting will start a 3:00 PM, with Open Regular Session Meetings starting at 7:00 PM, via Zoom, in person or hybrid; and

WHEREAS, Extra Meetings (if needed) will begin at 7:00 PM, via Zoom, in person or hybrid; and

WHEREAS, regarding COVID-19 (Coronavirus) and the corresponding closure of Princeton's municipal facilities, until further notice all meetings of the Princeton Mayor and Council will be held electronically via "Zoom" instead of in person. Instructions for how to access each meeting will be posted on Princeton's website (www.princetonnj.gov <http://www.princetonnj.gov>) and set forth on the meeting agenda;


