



RESOLUTION 22-80

Resolution Amending Resolution 22-50, Award of Contract to Precision Technology Solutions for Parking Equipment Upgrades at the Spring Street Garage, to Increase the Contract Amount to \$33,010.00

WHEREAS, the Municipality of Princeton (“Princeton”) desires to procure goods and services necessary to complete upgrades to the certain equipment at the Spring Street Garage; and

WHEREAS, by Resolution 22-50 adopted on January 24, 2022, the Princeton Council awarded an agreement to Precision Technology Solutions to provide the sought-after equipment and render services including installation of said equipment for a not to exceed cost of \$32,010.00; and

WHEREAS, the Agreement has not yet been signed, and Princeton Technology Solutions submitted an updated proposal on February 7, 2022 increasing the proposed not to exceed contract amount by an additional \$1,000.00, bringing the not to exceed amount to \$33,010.00, to ensure the payment of prevailing wages to the contractor’s workers, as required by law; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available to pay for said services from 06-215-18-009-301.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Municipality of Princeton, County of Mercer, State of New Jersey, as follows:

1. Resolution 22-50 is hereby amended to increase the not to exceed contract amount by an additional \$1,000.00 to be paid for upgrades to certain equipment at the Spring Street Garage.

2. The Mayor and Clerk are hereby authorized and directed to execute an agreement with Precision Technology Solutions of Ambler, Pennsylvania, to provide the sought-after goods and services, consistent with this Resolution, Precision Technology Solutions' amended proposal dated February 7, 2022, and the above "Whereas" clauses.
3. Precision Technology Solutions shall be paid a fee not to exceed \$33,010.00.
4. A copy of this Resolution and the agreement shall be placed on file in the Office of the Clerk.
