



RESOLUTION 22-103

Resolution Authorizing the Acceptance of a Preserve New Jersey Capital Level II Grant Award for the Project Entitled “Princeton Ice Company (Stone Arch Bridge)”, Committing to the Dedication of up to \$395,218.00 in Matching Funds, and Authorizing the Mayor to Sign the Acceptance Documentation

WHEREAS, the Billy Johnson Mountain Lakes Nature Preserve contains the historic landscape of the Princeton Ice Company which includes dams and bridges; and

WHEREAS, a historic stone arch bridge require rehabilitation and / or reconstruction to continue to provide non-motorized access to Princeton’s open space; and

WHEREAS, by Resolution 21-147, the Mayor and Council of the Municipality of Princeton authorized the Municipal Engineer to submit a New Jersey Historic Trust Preserve New Jersey Capital Level II Historic Preservation Fund grant application to request grant funding for a project entitled “Princeton Ice Company (Stone Arch Bridge)” to rehabilitate said structure; and

WHEREAS, on December 21, 2021, the Governor approved legislation to fund the selected Preserve New Jersey Historic Preservation Fund grant projects, which includes the Princeton Ice Company (Stone Arch Bridge) project; and

WHEREAS, the grant funds awarded in the 2021 Preserve New Jersey Capital Level II Historic Preservation Fund program are available for disbursement from the New Jersey Historic Trust; and

WHEREAS, the Mayor and Council of Princeton desires to further historic preservation through acceptance of Grant No. 2021.2076 from the New Jersey Historic Trust, State of New Jersey in the amount of \$395,218.00 for the Princeton Ice Company (Stone Arch Bridge) project.

NOW THEREFORE BE IT RESOLVED, the Princeton Council authorizes Mayor Mark Freda to execute a grant agreement with the State in an amount up to that awarded for the proposed project, and to seal the grant agreement.
