



RESOLUTION 22-106

Resolution Authorizing the Award of a Contract to Hydra-Numatic Sales Company to Furnish Equipment for the Supervisory Control and Data Acquisition (SCADA) System for Pump Stations in the Amount of \$16,884.72

WHEREAS, the Municipality of Princeton ("Princeton") has the need to replace the copper wire dialer systems used at the sanitary sewer pump stations; and

WHEREAS, the Sewer Department recommends that a Supervisory Control and Data Acquisition (SCADA) System be procured as a replacement; and

WHEREAS, in response to a solicitation for quotes, Princeton received the following three (3) quotes, to furnish said SCADA system for:

1. Hydra-Numatic Sales Company - \$16,884.72;
2. PCS Pump and Process, Inc. - \$20,595.60; and
3. RACO Remote Alarms and Controls - \$30,555.00;

WHEREAS, Hydra-Numatic Sales Company provided the lowest quote to Princeton for purposes of the sought after purchase in the amount of \$16,884.72; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available to pay for said purchase in capital account 04-215-19-019-089-302 (\$14,190.12) and from operational account 01-201-31-455-268 (\$2,694.60); and

WHEREAS, this contract award is exempt from public bidding pursuant to N.J.S.A. 40A:11-3a. and 40A:11-6.1a. because the contract amount does not exceed the bid threshold; and


WHEREAS, Princeton wishes to award a contract to undertake and complete said

purchase from the aforementioned vendor with the lowest responsible quote.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Municipality of Princeton, County of Mercer, State of New Jersey that a contract to furnish equipment for the Supervisory Control and Data Acquisition (SCADA) for the pump stations in the amount of \$16,884.72 is hereby awarded to Hydra-Numatic Sales Company, 22 Park Place, PO Box 760, Butler, New Jersey 07405, without public bidding as permitted by law.
