



RESOLUTION 22-130

Resolution of the Mayor and Council of Princeton Authorizing the Award of a Contract to NDL Maintenance Services, LLC for the Princeton Spring 2022 Planting Project in the Not to Exceed Amount of \$39,200.00

WHEREAS, in response to a duly advertised Notice to Bidders under the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11- 1 et seq., on March 9, 2022 Princeton received the following four (4) bids for the Municipality of Princeton Spring 2022 Planting Project consisting of 85 deciduous three-inch caliper street trees to be planted throughout the Municipality. The location of trees to be planted is determined by the Municipal Arborist and by resident requests.

1. NDL Maintenance Services, LLC, Kingston, New Jersey in the amount of \$39,200.00
2. Sunset Creations, Belle Mead, New Jersey in the amount of \$42,515.00
3. Aspen Landscaping Contracting, Inc., Union, New Jersey in the amount of \$70,070.00
4. Mikes Country Market, Milltown, New Jersey in the amount of \$76,755.00; and

WHEREAS, the Municipal Arborist has reviewed NDL Maintenance Services, LLC 's bid and recommends that the contract be awarded to NDL Maintenance Services, LLC as the lowest responsible bidder; and

WHEREAS, the Municipal Attorney's Office has reviewed the bid submitted by NDL Maintenance Services, LLC and finds that its submission is in compliance with the bidding requirements for same; and

WHEREAS, Princeton's Chief Financial Officer has certified that sufficient funds in the total amount of \$39,200.00 are available for this project from capital accounts 04-215-17-037-075-322 (\$1,502.75), 04-215-18-007-075-322 (\$30,862.24), and 04-215-19-021-075-340


(\$6,835.01).
