RESOLUTION 22-207

Resolution of the Mayor and Council of Princeton Approving the Governor's Council on Alcoholism and Drug Abuse DMHAS Youth Leadership Grant

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse (GCADA) established the Municipal Alliances for the Prevention of Alcoholism and Drug Abuse in 1989 to educate and engage residents, local government and law enforcement officials, schools, nonprofit organizations, the faith community, parents, youth and other allies in efforts to prevent alcoholism and drug abuse in communities throughout New Jersey. In coordination with GCADA, the New Jersey Department of Human Services/Division on Mental Health and Addiction Services (DMHAS) has awarded a Youth Leadership Grant to the GCADA Municipal Alliance Program.

WHEREAS, The Township/Borough/City Council of the Township/Borough/City of Princeton, County of Mercer, State of New Jersey recognizes that the abuse of alcohol and drugs is a serious problem in our society amongst persons of all ages; and therefore has an established Municipal Alliance Committee; and,

WHEREAS, the Township/Borough/City Council further recognizes that it is incumbent upon not only public officials but upon the entire community to take action to prevent such abuses in our community; and,

WHEREAS, the Municipality of Princeton Council has applied for DMHAS Youth Leadership funding through the Governor's Council on Alcoholism and Drug Abuse through the County of Mercer;

NOW, THEREFORE, BE IT RESOLVED by the Municipality of Princeton, County of Mercer, State of New Jersey hereby recognizes the following:

1. The Municipality of Princeton Council does hereby authorize submission of an application for DMHAS Grant funding for the Princeton Alcohol and Drug Alliance Municipal Alliance for Year One Grant Term 7/1/22 - 3/14/23 in the amount of:
DMHAS Grant Funding \$9,244.00
2. The Municipality of Princeton Council acknowledges the terms and conditions for administering the Municipal Alliance grant, including the administrative compliance and audit requirements.


